PROCEEDINGS OF THE TENDER COMMITTEE MEETING FOR OPENING OF TECHNICAL BID FOR ENGAGEMENT OF BLOCK WISE TRANSPORT CONTRACTOR UNDER MDM PROGRAMME FOR THE YEAR 2018-19, HELD IN THE CONFERENCE HALL OF SSA, CUTTACK ON DT. 21/02/2018 AT 3.30 P.M.

The tender Committee meeting was held under the Chairmanship of Sj. R.Raghuram Iyer, O.A.S. – I (SG), A.D.M. (R), Cuttack on Dt. 21.02.2018 at 3.30 p.m. in the Conference hall of SSA, Cuttack. The following Committee members were present in the meeting.

The bidders as well as their authorized representatives have attended the meeting. The attendance sheet is at Annexure – “A”.

As per kind orders of Collector & District Magistrate, Cuttack, the Block wise tender call notice for engagement of Block wise Transport Contractor for transportation of MDM rice for the year 2018-19 was invited vide Notification No. 2119, Dt. 29.01.18. The tender call notice was published in the daily newspaper “The SAMAJ” and “SAMBAD” on Dt. 05.02.18 and hoisted in the District website <http://cuttack.nic.in> for wide publication.

At the outset the Chairman welcomed all the members and the bidders present in the meeting and advised to start the tender process. It was found that 33 (Thirty three) number of bids received through Speed Post / Regd. Post in respect of 12 nos of Block and Cuttack Municipal Corporation within the stipulated time. The sealed quotations were opened in presence of tender Committee members and bidders / authorized agents present. Packets containing technical bid and EMD were placed on the table for scrutiny. Price bid (33 nos) were kept inside the box and duly sealed. After verification of required documents, the Block wise comparative statement was prepared as per **Annexure-B**.

The documents furnished by the bidders were thoroughly scrutinized and found that the following bidders (four) have not furnished the required documents as per the terms and conditions of the tender. Then the Committee members discussed at length and unanimously decided to disqualify the said bidders for deficiency of documents as mentioned below:-

Further one bidder i.e. Sri Laxmidhar Hota has submitted the tender against the Blocks like Banki - Dompada, Mahanga, Athagarh, Banki & Tigiria but has submitted one solvency certificate worth Rs. 6.00 lakhs in each Block. So after discussion the Committee unanimously decided to disqualify the said bidders for those Blocks for unique solvency.

That in case of Baranga & Cuttack MPL Corporation single bid for the first time in this advertisement has been received in each case and in case of the Blocks like Narasinghpur, Banki, & Cuttack Sadar only single bid has been qualified to the price evaluation. So the Committee unanimously decided to cancel the bids against the Blocks as above.

Apart from above the following bidders (19 nos) have furnished all requisite documents as per the terms & conditions of the tender and accordingly the Committee unanimously decided to qualify them in technical bid for participating in Price bid.



PROCEEDINGS OF THE "TENDER COMMITTEE MEETING FOR OPENING OF PRICE BID FOR ENGAGEMENT OF BLOCK WISE TRANSPORT CONTRACTOR UNDER MDM PROGRAMME FOR THE YEAR 2018-19 HELD IN THE CONFERENCE HALL OF SSA, CUTTACK ON DT. 03.04.2018 AT 10.30 A.M.

The tender Committee meeting for opening of Price Bid for engagement of Block wise Transport Contractor under MDM Programme for the year 2018-19 was held in the conference hall of SSA, Cuttack on Dt. 03.04.18 at 10.30 a.m. under the Chairmanship of Sj. R.Raghuram Iyer, O.A.S. - 1 (SG), A.D.M. (R), Cuttack. The list of members of the tender Committee who attended the meeting is annexed at Annexure - "A". All the bidders / authorized representatives were also present in the meeting which is annexed at Annexure - "B".

The list of the bidders and the defects detected during scrutiny of technical bid were read out in the presence of the bidders. Before opening of price bid, the list of 5 (Five) no. of bidders who had disqualified in the technical bid was announced in the meeting. But during the bidding process one Sri Pramod Kumar Sahoo who had applied the tender against three Blocks i.e. Salipur, Mahanga & N.Koili but submitted the solvency certificate of Rs. 9.00 lakhs. By oversight initially the said bids were accepted inadvertently by the Committee but when objection was raised that solvency certificate for 3 Blocks as per rule should have been Rs. 15.00 lakhs instead of Rs.9.00 lakhs the Committee unanimously resolved to reject the bids of Sri P.K. Sahoo and therefore cancelled the entire tender process against those 3 Blocks. Furthermore it was decided by the Committee for call for fresh tender for those 3 Blocks i.e. Salipur, Mahanga & N.Koili.

Moreover as the tender against the Blocks like Baranga, Cuttack MC, Narasinghpur, Banki & Cuttack Sadar had already been cancelled by the Committee due to single bid for the F.Y. 2018-19 as per the Proceedings of the technical bid, it was decided by the Committee for call for fresh tender for those 5 Blocks too.

The sealed box containing Block wise price bids of the rest of the Blocks were opened. The rates quoted by the bidders for each Block have been recorded separately and also announced in the meeting. Then the Comparative statement of price bid was prepared which is annexed at Annexure - "C".






On scrutiny of Comparative statement of Price Bid it was observed by the Committee that, the rate quoted by the bidders in favour of the Blocks like Athagarh, Tangi - Choudwar, Tigiria, Badamba & Banki-Dompada appeared to be less in comparison to the previous year rate. The bidders with lowest quoted rate in favour of the said Blocks were present and the Committee accepted the rate as mentioned below and unanimously accepted the following (5) bidders as L1 bids. And accordingly it was decided by the Committee that the E.M.D. in favour of the unsuccessful bidders will be returned.
