In pursuance of Govt in Revenue and Disaster Management Department L No 18284 Dt 06 05 10 & No 9003 Dt.26 02 11 & in conformity with the OMS(Method of Recruitment to the post of Junior Clerk in the District Offices) Rule-1985 & amendment Rule 2009 & pursuant to the recommendation of Board of Examiners of Recruitment Board, the following selected candidates are here by appointed as Junior Clerks in various Offices of this District carrying the pay scale Rs 5200-20200/- with G P Rs 1900/- per month with usual D A as admissible from time to time without prejudice to the claims of others They are posted to the Offices as noted against each of them
