

The Joint Director, Frozen Semen Bank, Cuttack (herein after referred as "JOINT DIRECTOR") invites sealed tenders in the prescribed forms from the MANUFACTURERS / Authorized distributors (herein after referred as "Tenderer") having valid manufacturing license, VAT clearance certificate as per OVAT Act, GST number, or as per tender conditions, for supply of LIQUID NITROGEN to the Joint Director, Frozen Semen Bank, Khapurua, Cuttack, for the year 2018-19 at destinations as per Table – 1. The Tenderer are requested to quote their rate towards cost of LN₂ including the delivery charges at the different destination points as maintained in Table-1. The Budget Provision for procurement of LN₂ is approximately Rs.1.50 core, which may vary according to actual requirement quantity of LN₂.

1. The Liquid Nitrogen should have minimum 99.5% purity and -196⁰ C boiling point.
 2. The rate is per MT (Metric Ton) F.O.R. at destination point. Rate shall include all relevant taxes & transportation charges as applicable.
 3. Rate per MT (Metric Ton) may please be quoted for F.O.R. destination on the Road Cryo Tanker/ Transport Cryo Container of the Department as required at destinations as detailed below with monthly/ yearly approximate requirement. It may please be noted that, escalation of rate due to increase in diesel and lubricant will not be paid during the agreement period.
 4. The cost of Liquid Nitrogen will be paid only on the net quantity received at the destination by weighing the transport vehicle with the vessel and deriving the quantity. Thus, the transit evaporation is to be borne by the Tenderer.
 5. The supply shall be made through the branches having GST/VAT/CST RC in the State of Odisha.

ELIGIBILITY

For Participation in the Tender.

1. The Tenderer should be a MANUFACTURER/AUTHORISED DISTRIBUTOR having valid registration of the product and valid manufacturing license. Authorized distributor who are interested to participate have to obtain necessary authorization from manufacturer along with the copy of manufacturing license of the manufacturer from whom the liquid nitrogen are to be procured for supply. In case the manufacturing firm delegates to file tender to any local distributor, the firm has to submit an authorization letter of delegation in original addressed to the Joint Director, Frozen Semen Bank,



- Khapuria, Cuttack – 753010 being passed by resolution of its Board of Director or through its Managing Director or Marketing Manager or any other Executive of the manufacturer.
2. Wherever applicable, the manufacturing company must have quality certificate for specified quality standards. (e.g. Quality Certificate and Purity Certificate) Analysis report of competent authority or authorized Government Agencies regarding Quality/Purity should be enclosed.
 3. The registration certificate of the manufacturing company must indicate that production of Liquid Nitrogen is commenced. Only provisional Registration of the LN₂ without commencement of production of LN₂ is not sufficient.
 4. The manufacturing firm must be a manufacturer of the Liquid Nitrogen for a period of minimum of last three years' and be in domestic market in India with minimum annual turnover not less than Rs.0.50 crore for each year, in respect of preceding 3 years.
 5. The outside participants should have their branches having GST / VAT RC / CST RC in the State of Odisha or else the selected firms has to give an undertaking to open a branch inside the State before award of Purchase Order as per SGST / OVAT Act.
 6. The Tenderer must have not been blacklisted by any Govt. Offices/ Govt. undertakings / Organizations/Institutions of local self Government/Public sector in INDIA. In case it is detected later on that the participant firm is a blacklisted one, the Tender submitted by such Tenderer would be rejected forthwith and Earnest Money and/or Security Deposit would be forfeited to Government in addition to such legal action will be taken as deemed fit and proper. The Tenderer should submit declaration in this regard in Non Judicial Stamp Paper as per Format-2.
 7. The Tenderers must have experienced in supplying of LN₂ to Govt./Semi Govt. Organizations, PSUs and UNO Agencies at least for last three years.
 8. The tenderer must have minimum annual turnover of 0.50 crores for preceding three years.
 9. The Tenderer has to submit G.M.P. certificate.

For submission of tender

There shall be two bid systems. i) Technical-Bid and ii) Price-Bid.

I) Technical Bid

The tenderer have to give detail catalogue, information, manufacturing details, as per schedule along with annexure and detail required documents.

II) Price Bid

The Tenderer should quote the price of Liquid Nitrogen in separate sheet as per Annexure –VI for each destination applied for, the price offered for tender must be mentioned which must include basic manufacturing price, Excise duty, CST, GST if any & any other tax alongwith cost of transportation & forwarding charges. The GST / VAT shall be charged as per guidelines given by Finance Department, Govt. of Odisha from time to time.

In the first stage, the Technical Bids are to be opened by a committee at the scheduled date and time in presence of Tenderer or authorized representative of Tenderer. At the second stage, Financial Bids of only Tenderer will be opened whose Technical Bids/ offers accepted by the Committee for further evaluation and ranking before awarding contract by purchase committee of the Joint Director, Frozen Semen Bank, Khapurua, Cuttack in scheduled date and time in presence of Tenderer or authorized representative of tenderer.



EARNEST MONEY DEPOSIT (EMD)

The Tenderer is required to deposit of EMD an amount of **Rs.4, 00,000/- (Rupees four lakh only)** as per the guidelines of the Government at the time of submission of Tender in lumpsum as per the following manner.

Fixed Deposit receipt of Commercial Bank./

Post Office Savings account./

National savings Certificate./

Post Office term deposit account.

The EMD is to be pledged in favour of "The Joint Director, Frozen Semen Bank, Khapuria, Cuttack".

In case of Small Scale Industries/ Micro, Small and Medium Enterprises registered with the Director, E.P. & M, Odisha will be eligible for exemption from payment of EMD in respect of the item covered in their certificate of registration subject to production of photocopy of registration certificate such as PMT Certificate /E.M.-II Acknowledgement from Director of Industries, Odisha.

Payment of Earnest Money in any other form (other than as specified above) shall not be accepted in any case. The Earnest Money to be deposited in shape of postal saving pass book/term deposit account shall stand recorded in the name of the firm and should not stand recorded in favour of any individual irrespective of the fact he is either a proprietor or a partner of the said firm. But Earnest Money Deposit in shape of N.S.C. recorded in the name of individual can be entertained.

The Tenderer shall not be entitled to claim any interest on the Earnest Money.

The Earnest Money deposited by unsuccessful Tenderer will be refunded as early as possible after the tenders are finalized and after approval of the Joint Director, Frozen Semen Bank, Khapuria, Cuttack.

Earnest Money deposited by the successful Tenderer shall be retained & will be returned after expiry of the approved period or as per approval of the Joint Director, Frozen Semen Bank, Khapuria, Cuttack.

The EMD will be forfeited if the Tenderer withdraws the tender or does not accept the approved rate or does not supply the items within the stipulated time as per the terms & conditions of tender or the product supplied is proved to be of substandard quality.

RIGHT OF ACCEPTANCE/REJECTION OF TENDER

The following documents shall be submitted by the tenderer as a MUST alongwith tender papers.

1. EMD (Earnest Money Deposit) or necessary document from concerned authority towards exemption of EMD.
2. Original money receipt/ Bank Draft in respect of purchase/downloading of tender documents.



3. Attested Photocopy of the up-to-date manufacturing license of the manufacturer from competent authority.
4. Attested Photo copy of up to date PAN card & Income Tax return for last three financial years.
5. Attested Photocopy of up to date GST / Sale Tax clearance Certificate / VAT clearance certificate.(in case of tenderer is exempted from GST/ sales tax/VAT or if he enjoys the benefit of deferment, he must submit documentary evidence to the effect)/ outside State bidders can produced 612-A OVAT Act or furnish an undertaking in Non-Judicial Stamp Paper if selected will supply goods, by opening branches/ Sales Depot as per OVAT Act in State of Odisha.
6. Attested photocopy of GST / C.S.T. & VAT R.C.
7. Duly filled Tender Form alongwith declaration and all Annexure.
8. Photocopy of i) Original Authorization Certificate ii) Manufacturing license of the original manufacturer in case of the tenderer is a authorized distributor.
9. Photocopy of Annual Turn Over disclosed in VAT Returns of last three years or Balance Sheet of the audited Account of last three years.
10. Declaration regarding not blacklisted by any Govt. Offices/ Govt. undertakings / organizations in Non Judicial Stamp Paper.
11. Documentary evidence in support of minimum annual turnover of Rs.0.50 crore for preceding 3 years in supply of items of Liquid Nitrogen.
12. Experience certificate of supplying the Liquid Nitrogen for not less than three (3) consecutive years to Government/ semi Government Organizations/ UNO Agencies/ PSUs etc.
13. Photocopy of Quality/Purity Certificate.
14. Photocopy of Analysis Report of competent authority or authorized Government agencies regarding quality /purity should be enclosed.
15. Photocopy of GMP Certificate.
16. All documents should be attested by a Notary Public with seal.

No tender shall be accepted if the same is not supported with the above documents mentioned at SL. No.1 to 16. However the authority reserves the right to relax any clause for the public interest.

The right of acceptance of tender and award of contract rests with the Joint Director, Frozen Semen Bank, Khapuria, Cuttack, who does not bind himself to accept the lowest tender and also reserves himself the right to reject any or all the tender(s) received without assigning any reason whatsoever. Any dispute arises in future will be finalized by the Joint Director. The legal dispute is subject to Cuttack jurisdiction only.



SECURITY DEPOSIT

The successful Tenderer shall have to furnish the Security Deposit of 5% (five) on the value of goods indented, in the manner mentioned below within 10 (Ten) days from the date of receipt of each indent.

Fixed Deposit receipt of Commercial Bank./

Post Office Savings account./

National savings Certificate./

Post Office term deposit account./

Bank Guarantee from any Commercial Bank (model format No.-4 can be used)

All the security must be pledged in favor of "The Joint Director, Frozen Semen Bank, Khapuria, Cuttack". .

The local MSEs registered with respective DICs/ Khadi, Village, Cottage & Handicraft industries, OSIC, NSIC shall pay 25% of the prescribed Security Deposit.

In the event of failure of payment of Security Deposit, the order is to be treated as cancelled and steps will be taken to procure from other sources. The successful tenderer shall not be entitled to claim any interest money on the amount of Security Deposit.

The Security Deposit will be released & returned back to the tenderer as per Rules of OGFR volume-I/ code-22 of FD circular 4939/F/13.2.2012 and as per order of the Joint Director, Frozen Semen Bank, Khapuria, Cuttack. The Security Deposit shall be forfeited in case the item of supply is found to be of sub-standard quality by the competent authority and if the supplier fails to supply indented items in time to the satisfaction of the Indenting Officer.

SIGNING OF AGREEMENT/ INDEMNITY BOND

- i) The successful tenderer will be required to execute an agreement bond on non judicial stamp paper worth Rs.500/- in the appropriate proforma available at office of the Joint Director, Frozen Semen Bank, Khapuria, Cuttack.
- ii) Indemnity bond will be required to be given by the party agreeing and assuring that in case of any complaint of losses, the contractor will pay the same to the indenting authority.

LIQUIDITY DAMAGE CLAUSES

1. It is a condition of the contract that all through the currency thereof, the ex-factory price at which you will supply the stores should not exceed the lowest price charged by you to any customer during the currency of the rate contract and that in the event of the prices going down below the rate contract prices, you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.
2. For enabling the undersigned to monitor this aspect, the tenderer shall have to undertake to promptly supply a copy of its rate-list applicable to its distributors/ whole sellers and retailers along with all kinds of discount structure including quantity discount, early payment discount, cash discount, business incentives etc and also undertake to furnish promptly a copy of all rate-contracts in force at any point of time during the currency of contract with the undersigned.



VALIDITY OF TENDERS

- i. The offer price of all the Tenderer shall remain valid for acceptance for a period of 12 months from the date of publication of the Tender Notice by the Joint Director, Frozen Semen Bank, Khapuria, Cuttack. The approved list of which will remain valid for a period of 12 month or publication of next approved list of such items whichever is later. However, if next approved list is delayed for publication beyond the 24 months as per the date line, the terms, conditions alongwith the approved price of the items as found place in the approved list may be extended against a specific period as decided by the Government.
- ii. No extension of time shall be allowed for submission of Tender under any circumstances unless otherwise specifically extended by the JOINT DIRECTOR by an advertisement in such Indian News Papers as JOINT DIRECTOR may consider necessary or in such other manner as may deemed it fit and proper.

TENDERER'S UNDERSTANDING OF THE TENDER DOCUMENT

The tenderer shall carefully go through the tender documents and fully informed himself to all the terms and conditions contained there in before submission of the tender. If the tenderer find discrepancies or omission or should be in doubt as to their meaning relating to tender documents, he should at once inform the JOINT DIRECTOR and obtain clarification in writing prior to submission of this tender. Verbal clarification or information given by the JOINT DIRECTOR or the employees working under him or his representatives shall not be binding on the JOINT DIRECTOR.

NO CLAIM OF COMPENSATION FOR SUBMISSION OF TENDER

No Tenderer shall be entitled to claim any cost, charges, expenses etc. incurred by him or incidental therein connection with submission of this tender even though the JOINT DIRECTOR may elect to withdraw the invitation of Tender, without notice and without assigning any reason whatsoever.

TERMS AND CONDITINS FOR SUBMISSION OF TENDERS FOR SUPPLY OF LIQUID NITROGEN FOR 2018-19

The Tenderer should read carefully all the terms & conditions before preparing the tender documents for participation in the tender.

A. Instructions to Tenderer while purchasing/downloading.

- I. Each set of Tender documents are serially page marked. The Tenderer should check the documents immediately after purchasing/downloading of the same. If there are any lapses, the Tenderer should immediately report the fact to the Joint Director for its rectification if any.
- II. The original money receipt obtained towards cost of Tender Papers should be carefully retained and should be submitted in Original at the time of submission of tender documents.

B. Instructions to Tenderer while submitting the Tender Papers.

1. It is the duty of Tenderer to sign in all pages with seal. It is mandatory to sign with seal & date where it is clearly mentioned and also in all supporting documents submitted along with annexure.
2. Capital letters should be used in filling up of the tender form and should be neatly typed/ computerized/ hand written.
3. All corrections, additions, alterations in the tender documents shall be authenticated by initial/ signature of the Tenderer.
4. Rates should be quoted on the prescribed tender form (Annexure-VI). The rates offered should be written both in figures and in words and no erasing or overwriting shall be entertained.
5. All information in these tender documents shall be in English only.
6. Tenderer, if desires may cite the Brand name /specification if any(Annexure-II).
7. Tendering firm should quote the item which is in the MANUFACTURING LICENSE. In case of quoted items from overseas manufacturers/ MNCs, it is required to submit an undertaking to furnish the manufacturing license before awarding of purchase order, if selected.
8. The rate to be quoted should be **F.O.R. destination at FSB, Cuttack , FSB, Chiplima, CDVO, Balasore, CDVO, Ganjam (Berhampur), CDVO, Koraput and CDVO, Kalahandi (Bhawanipatana) under the Directorate of Animal Husbandry & Veterinary Services, Odisha, Cuttack inclusive of packing, forwarding, transportation charges & all taxes.** The rate should be quoted in Indian currency only. It is necessary that specific brand, make etc. should be clearly mentioned on the tender paper for each item furnished to compare the composition and the rate against multiple offers.
9. The Tenderer must quote the rates of the items for which they have been specifically asked for as per tender schedule. Tenderer quoting the rates or units different from those mentioned in the tender schedule may be liable to be rejected. Tender containing clerical error / typographical error/ arithmetical mistake (s) may be liable to be rejected.
10. Tenderer who are manufacturers of the Liquid Nitrogen to be supplied by them must furnish attested copy of the certificate from the appropriate licensing authority or DIC




along with the tender documents confirming that they are actually manufacturing these Liquid Nitrogen.

11. The Tenderer shall quote the tender price at Annexure-VI, which shall be inclusive of basic rate, excise duty, packing & forwarding and transportation charges & any other taxes. The GST / VAT shall be charged as per guidelines given by Finance Department, Govt. of Odisha from time to time, on the face of the invoices submitted and such Odisha VAT / GST only will be paid to the supplier exclusive of quoted price. In case of Entry tax, the Tenderer has to deposit the Original Money receipt/payment chalan towards payment of Entry Tax in Odisha State & Entry Tax shall be paid to manufacturer of Odisha State as prescribed in OET Act. In case of outside dealers approved in the tender shall supply the goods through their branches/sales depot having VAT, RC in the State of Odisha. The outside State bidders have to submit an undertaking in Non-Judicial Stamp Paper that if selected will supply goods, by opening branches/ Sales Depot as per OVAT Act in State of Odisha.
12. In case there are really different compositions or Brands to be offered against one item and all of them confirm to the standard and specification of the required item more than one rate can be offered for consideration. But the Tenderer in all such cases shall clearly mention the make, brand, specification and shall furnish literature /brochure regarding liquid nitrogen.
13. The Tenderer is required to submit detail product brochures & leaflets providing detail information about the liquid nitrogen to be supplied alongwith warranty / guarantee if any, as per Tender alongwith the Technical Bid for scrutiny by the Technical Committee and further consideration of purchase committee, failing which the items so offered will not be considered.
14. Detail facts about machinery available for production and supply of stores & per day production capacity.
15. The price preference for S.S.I. units / MSESs located inside the state of Odisha and additional price preference for S.S.I. unit/ MSESs having I.S.I. marks for the particular product will be given in accordance with the Government industrial Policy/ Resolution in vogue. The Tenderer who are S.S.I. units / MSESs should submit relevant documents from the appropriate authority alongwith the tender documents stating the Permanent Registration number and Date and the names of the items for which registered. The word S.S.I. unit / MSESs should be marked in **Red Ink on the right hand top corner of the Tender documents.**
16. The Tender filled by the proprietorship concerned should be signed by the sole proprietor
or
should be signed by the any partner in case of Partnership firm
or
by Managing Director or Board of Director along with the authorization by means of Board of resolution in case of company.

In case of Partnership firm, the copy of partnership deed to be submitted.

or



In case of company Copy of the Certificate of incorporation should be furnished in support the firm being registered under the companies Act.

17. Submission of more than one Tender by a particular Tenderer under different names is strictly prohibited. In case it is found later on that this condition has been violated, all the tenders submitted by such Tenderer would be rejected or cancelled and Earnest Money and/or Security Deposit forfeited to Government in addition to such legal action will be taken as deemed fit and proper.
18. Tenders directly received from the manufacturers will be given preference subject to they have branches/sales depot with GST / VAT /CST RC in the State of Odisha. Tenders of any firm newly constituted, inexperienced and without credibility will be rejected. The Manufacturers / Authorized distributors having valid registration should have minimum three years experience in supplying Liquid Nitrogen to Government / Semi Govt. Organizations, PSUs, UNO Agencies etc. Besides, they should have to submit proof of annual turnover of minimum Rs.0.50 Crores in supply of Liquid Nitrogen in each financial year for preceding 3 years in support of establishing the soundness of the firm and its business credibility towards competition in the tender.
19. Also, the Tenderer shall furnish a brief write-up supported with adequate data and documentary evidence explaining and establishing his credentials, manufacturing capacity, quality control systems, financial background, past performance, available capacity both technical and financial to perform the supply contract (if awarded) within stipulated time period.

The SSI units and MSMEs in conformity with MSMEs Policy,2009 and IPR 2007 registered with Directorate of EPM in respect of the items covered in their certificate should have annual turnover of Rs.10.00 lakh for supply of such items for preceding 3 years for participation in the tender.

20. 22. - Frozen Semen Bank, Cuttack and to furnish a Security Deposit @ 5% (Five percent) of the value of one purchase order as per manner already mentioned.
26. If at any time during the period of contract, the price of any tendered item is reduced or brought down by any law or act of the Central or State Government or the Tenderer, the Tenderer shall be morally and statutorily bound to inform the Joint Director, Frozen Semen Bank, Cuttack immediately about such reduction in the contract price. The Joint Director, Frozen Semen Bank, Cuttack is empowered to unilaterally effect such reduction as is necessary in rate, in case the Tenderer fails to notify or fails to agree for such reduction of rate.

 31. Abnormally low price of the item quoted by the tenderer in the Tender with some malafide intention will not be accepted, if detected and his offer will be rejected.

However, if the undersigned desires to inspect the material, the manufacturing facility and stores should be offered for inspection to him or to his agent. Supplier will have to bear the charges of inspection & Testing wherever necessary.

Random sampling by person authorized by the Director, under intimation to the supplier or his representative may be done, if required and the same will be tested at any of the labs approved by Government of India or its agencies and the cost of such inspections will be borne by the successful Tenderer

36. Successful Tenderer will have to supply the LN₂ as per order placed, within the stipulated period mentioned in the supply order and failure to do so without sufficient reasons, the penalty of 1% of value will be charged per couple of days or part thereof for late delivery of goods till the date of its supply / receipt. However, the quantity to be purchased is likely to change as per the provision, sanction and requirement.

38. **FORCE MAJEURE-** If, at any time during the continuance of this contract the performance in whole or in Part by either party of any obligation under this contract shall be prevented or delayed by reason of any war, hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lock outs or acts of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event, be



entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance; and deliveries under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist, and the decision of the purchasing officer as to whether the deliveries have been so resumed or not, shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may at its option terminate the contract.
