Sealed tenders are invited in the prescribed format from the intending reputed firms/Agencies with the following terms & condition for

1. Supply of BPGY Logo tiles (15 X 15 Inch with 6 mm thickness) under Biju Pucca Ghar Yojana and delivery at all 14 Blocks of Cuttack district as per design types & specifications given by this Office.

The tender/bid documents completed in all respect will be received from **01.02.2019** to **11.02.2019** latest by 4.00 PM during the office hour in DRDA, Cuttack by way of **registered post/speed post/Courier service** only and will be opened on dt. **11.02.2019** at 5.00 PM in the presence of the committee member and bidders or their authorised representatives at the Conference hall of DRDA, Cuttack.

The request for proposal/ bid document format along with terms & condition, detail specification of AGAB Logo tiles and Eligibility criteria can be viewed/ downloaded from the district website i.e. **www.cuttack.nic.in** & Non-Refundable Demand Draft of Rs. 1000/- (Rupees One Thousand) only in favour of Project Director, DRDA, Cuttack payable at Cuttack shall be deposited along with the Bid Document towards Tender Paper Cost.

Terms & Conditions

1. The bidders must be a reputed firm/ Agency.
2. The bidder must have similar work experience.
3. The bidder can submit only one Bid. Multiple Bids submitted by any bidder shall result in rejection of all his bids.
4. The bidder must have been registered under Goods & Services Tax (GST) Act and must have a valid GSTIN number. The bidder must have a valid PAN/ TAN number.
5. The bidder must have minimum turnover worth Rs. 10 Lakh during the last 3(three) financial years. Copy of ITR of the firm for corresponding financial year/ copy of the Audited Financial Statement of last three financial year duly attested by the Chartered Accountant should be attached with the application.

6. The quotation shall be submitted in a sealed envelope/cover and **superscribed with “Supply of BPGY Logo tiles under Biju Pucca Ghar Yojana” to D.R.D.A., Cuttack.**
7. The quotation shall remain valid for a period not less than One Year after the deadline date specified for submission.
8. The quotation duly filled in with all required documents should reach the Office of The Project Director, DRDA, Cuttack latest by 4.00 PM on 11.02.2019. The sealed quotations received within the deadline will be opened on 11.02.2019 at 5.00 PM in the Conference Hall of DRDA, Cuttack in the presence of the committee member and bidders or their authorised representatives.
9. The bidder / representative of the bidder must submit a sample BPGY logo tile as per specification during the opening of the tender document.
10. Intending firms/suppliers may submit the quoted price in the prescribed proforma enclosed as Annexure-A along with copy of GST registration certificate, PAN card & all other required documents as specified in the Tender Advertisement.
11. The rate quoted should be inclusive of all taxes and other dues like transportation cost up to the delivery point i.e. all 14 Block Headquarters of Cuttack District.
12. The selected bidder has to supply of the items within 30 days from the date of issuance work order.
13. The purchaser will examine, evaluate and compare the quotations to received from the responsive Bidders and select the L₁ bidder taking in to consideration the lowest price quoted for all items taken together.
14. The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
15. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
16. The price quoted should be inclusive of cost of material to be supplied per unit & all taxes, & transportation cost upto all 14 Block Headquarters of Cuttack District.
17. A sum of Rs. 10,000/- (Rupees Ten thousand) only for supply of BPGY Logo tiles (15 X 15 inch with 6 mm thickness) under Ama Gaon Ama Bikash Scheme shall be deposited by the intending

18. The 2nd lowest bidder will be offered for supply of materials at the approved quoted price of the L1 bidder if the 1st lowest bidder fails to supply and this will be followed by forfeiting of EMD of the 1st lowest bidder.

 20. Payment will be made after receipt of the of BPGY Logo tiles (15 X 15 inch with 6 mm thickness) under Biju Pucca Ghar Yojana in good condition as per specification & sample soft-copy.
 21. The supplier should submit the Bank account details for transfer of funds.
