

**DETAILED TENDER PAPER FOR PRINTING OF NEW ARUNIMA ABHYASA
PUSTIKA -I & II FOR THE YEAR 2017-18.**

1. Detailed tender papers along with sample forms can be obtained from the Office of the DSWO, Cuttack from 07.03.2019 to 26.03.2019 from 10.30 A.M. to 3.00P.M. on any working day during office hours only on deposit of a non-refundable amount of Rs. 5000/- only.
2. The tender shall be received in the Office of the DSWO, Cuttack during Office hour on working days from dt 07.03.2019 to 26.03.2019 up to 5 P.M. through registered / Speed Post and the tender will be opened on 27.03.2019 at 3.00P.M. in the Office Chamber of ADM (Gen.), Cuttack in the presence of the Purchase Committee Members and the bidders or their authorized representatives. The tender received beyond the date and time shall not be taken into consideration.

4. The Tender paper should be submitted in sealed cover super-scribing in capital letters such as "**TENDER FOR PRINTING OF NEW ARUNIMA ABHYASA PUSTIKA -I & II.**"
5. The Tender paper should be filled in properly and legibly in plain paper / letter pad without any correction / over writing and must be typed / computer typed copy.
6. The price of printing charges is to be quoted for ONE Unit each.
7. The price quoted must be inclusive of paper cost / all taxes / duties / transportation cost etc.
8. The selected Printing Press will deliver the items at the Office of the Child Development Project Officers of Cuttack District within 15days from the date of indent . After composition of the format, the proof copy will be submitted in the Office of the DSWO, Cuttack for verification and approval.
9. The bidder has to submit the following documents and Sample Papers along with the tender paper :-

 - i) Original money receipt towards purchase of tender papers.
 - ii) Original tender paper duly signed by the tenderer as a token of acceptance of the terms and conditions of the tender.
 - iii) Attested copy of PAN Card.
 - iv) Attested copy of Income Tax return of last year.
 - v) Attested copy of up-to-date GST Certificate.
 - vi) Attested copy of Production Certificate from D.I.C.
 - vii) Sample Papers - A3 size 12 pages for each category as per specification.

11. The bidder has to give E.M.D. of Rs. 40,000/- (Rupees forty Thousand) only at the time of submission of Tender in shape of N.S.C. / Term deposit duly pledged in favour of DSWO, Cuttack. No bidder shall be allowed to withdraw his tender / earnest money until the tender is finalized. The E.M.D. of un-successful bidder shall be refunded where as the E.M.D. of successful bidder will be converted to Security Deposit.
12. The Security Deposit will be released after finalization of supply and settlement of Accounts.
13. The decision of the purchase committee regarding selection of the printing press will be final.
14. The successful bidder will deliver the items within 15 days of indent and failure to supply the materials may lead to forfeiture of security deposit / imposition of penalty.
15. Payment will be made within one month from the date of receipt of bills along with signed delivery challans of the CDPOs, subject to availability of funds and no interest will be paid for any delayed payment.
16. Any damage / torn / illegible etc. items detected during receipt will not be accepted.
17. In case of any dispute, the orders / decisions of the District Magistrate and Collector, Cuttack will be final and binding.
18. The Collector, Cuttack reserves the right to reject any or all the tenders without assigning any reason thereof.
19. Income Tax deduction would be done at source as per Govt. guidelines.
