If this day is declared later as a Government holiday then the quotations will be received and open the next working day as per the schedule time. The authority will not be held responsible regarding late submission/receive of quotation in any manner.

TERMS & CONDITIONS:

1. The envelope carrying the bid must be superscribed in capital letter "OFFER FOR AUCTION SALE OF VEHICLE" with address to **The Deputy Director of Agriculture, Cuttack, At/Po-Nayabazar, District:-Cuttack, Pin-753004**
2. The intending bidders are advised to inspect the above vehicle parked at place mentioned above between 11.00AM to 4.00PM from the dt.22.08.2019 to 30.08.2019 with contacting the Cell Phone bearing Number:-**0671-2442654** on all working days before submitting the quotation.
3. The intending bidders are required to pay a sum of Rs.2000/- (Rupees two thousand) only as earnest money deposit in shape of Bank Draft in favour of Deputy Director of Agriculture, Cuttack, payable at SBI Link Road Branch, Cuttack along with the quotation papers which will be refunded to the bidders whose quotations are not accepted except in case of successful bidder.
4. The amount offered by the bidders should be written clearly in words and figures. Any deviation in stating of facts and figures shall make the quotation liable for rejection.
5. The highest bidder whose quotation is accepted shall have to deposit immediately 25% of the quoted amount then & there as initial deposit through the manner by Bank Draft/Cash. He/she shall deposit the balance amount within seven days of deposit of the initial amount for issue of release order. In case, he fails to make deposit of the total amount as per the quotation within the stipulated time the entire deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment to the quoted value.



The successful bidder shall take permission and remove the vehicle for the office premises of the undersigned within seven days after realization of finalized quoted amount on failure to remove the vehicle within aforesaid time span, ground rent @1% of the quoted amount shall be charged for each day or part of the day till removal of the vehicle from the parking place. If the ground rent so charged, exceeds the sale price deposited, then the bidder shall cease to have any right on the vehicle and the amount deposited shall be adjusted towards ground rent and vehicle shall become absolute property of Government free from all encumbrances and disposed of by fresh auction sale process as the case may be.
7. The tools, instruments and spare parts shall not be delivered with the vehicle and the successful bidder has no rights to claim for such.




