

Background:

Odisha Rural Development and Marketing Society (ORMAS) was constituted in the year 1991 under Societies Registration Act, 1860 as an autonomous body under Panchayati Raj Department, Government of Odisha. ORMAS at District level known as “District Supply and Marketing Society” (DSMS). These units are functioning with the basic objective to help rural poor to make a better living by enabling them to improve their production, processing and marketing. DSMSs/ORMAS also act as a facilitating agency for implementation & monitoring of rural livelihoods programmes in rural Odisha.

An Exhibition in the most general sense is an organized presentation and display of selection of items. Exhibition/Mela has been part and parcel of entertainment and relaxation activity of our culture; ORMAS has used this medium as a channel to promote rural products made by the Institutions of poor.

ORMAS organises exhibition in collaboration with Odisha Livelihoods Mission (OLM), DC (Handicraft), KVIC, KVIB Department of H & CI, Department of Textile, Department of W&CD , Department of Industries and NABARD with an objective to provide a platform to the rural producers to showcase their products for direct sale, interact and get taste, choice & preferences of urban consumers. It also helps the rural entrepreneurs identify livelihood opportunities and establish links with the markets in urban and semi-urban areas.

The overall objective of the mela is to popularize the ethnic and other rural products of Odisha and create opportunities for the artisans/producers to build up long term marketing tie-up with prospective buyers.

Terms of Reference to the tender paper for the tentage & allied works of National Level Pallishree Mela 2019 at Cuttack

A.TERMS AND CONDITIONS OF TENDER FOR TENT & ALLIED WORKS

1. The firm/proprietor should have executed similar nature works of at least Rs.25.00 lakhs per annum consecutively in the last three financial years and out of that the firm/proprietor should have executed at least two work order of more than Rs.15.00 lakhs of Government departments/agencies /corporations within last three financial year.
2. The bidders should have registered his firm/proprietorship under GST (GSTIN), Income Tax (PAN/TAN). Copy of the valid GST Registration Certificate along with the copy of the upto-date return file under GST Act has to be enclosed.
3. The rate offered by the firm shall be inclusive of *all taxes and duties*.
4. The duration of the exhibition will be for 8 days. In case of any extension of Mela period, no extra payment will be entertained for the additional days. The venue shall be made available to the contractor by ORMAS-Cuttack before 15 days of commencement of the exhibition. All the desired works should be completed at least one day before the scheduled date and time of the inauguration of exhibition and should be handed over all the works as per specification, to the in-charge of exhibition.
5. The bidder shall quote their price for all the items without leaving blank. If found so, the bid will be treated as non-responsive and rejected.
6. The bidder has to quote the rate as per the given format.
7. On completion of the exhibition, the contractor shall have to take away all the materials within seven days & vacate the place with the same condition while occupying the ground.
8. The contractor should be prepared to provide additional materials in case of requirement at the market price for the items not mentioned in the tender.
9. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the Mela-in-charge. The contractor shall not use any additional materials other than the work specified in the work order without the prior permission of the Mela-in-charge. In case of any additional requirement, the contractor has to take the prior written permission from the Mela-in-charge.
10. The bidder along with manpower and the committee formed by the mela-in-charge should do a proper assessment and the actual work done during the mela period and the bidder has to cooperate for actual assessment else the payment will be made as per the assessment made by the committee formed by the Mela -in-charge.
11. Bidder will be responsible for upkeep and maintenance of the entire work done by him till the closing of the exhibition. ORMAS, Cuttack will not be responsible for any breakage, damage, fire, theft etc. of his materials and insurance if any.
12. No part of the contract will be sub-let without the prior written permission of the Mela-in-Charge.
13. For convenience and effective delivery, the tender is to be treated as a package of services. Evaluation of the competitive bidding price will be made taking into account the total amount calculated on the entire items.
14. It shall be the responsibility of the service provider/contractors to obtain requisite permission for electricity connection / fire services for the exhibition period from statutory bodies. The bidder has to supply the fire protection equipment like extinguisher as per the requirement of mela duly certified by the Asst. Fire Officer, Cuttack and adhere to the fire safety norms.
15. The bidder has to treat the materials to be used in Tentage work (like - Clothes), with Fire Repellant Chemicals. This work has to be certified by the Asst. Fire Officer, Cuttack.
16. With regard to electrical fittings etc. the contractor shall have to engage qualified licensed electrician/contractor entitled to erect, handle and maintain high tension supply line and its up keep and maintenance.

17. The bidders are required to deposit an earnest money of Rs.50,000/- (Rupees Fifty Thousand only) in shape of demand draft/pay order issued by any scheduled commercial bank in favour of “DSMS, CUTTACK” payable at Cuttack. The E.M.D. amount of the successful bidder will be kept with ORMAS, Cuttack till the completion of the exhibitions. In case of any unsatisfactory work, delay in execution of work etc. the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
18. The authority is not bound to accept the lowest tender and reserves the right to inspect / verify the stock of materials required for this work, in Go-down of bidders by nominating a Committee to ascertain the credibility of the firm. Further the undersigned reserves the right to reject any or all tenders without assigning any reasons thereof.
19. The bidder or the representative of the bidder should attend the opening event of the tender with all original documents / papers for verification, if required.
20. The rate offered by the firm shall be including of all taxes (like GST etc.) and duties as applicable. The price offered by the firm is valid for one year.

Light: 20 no. tube lights will be fitted in the poles.

Chair: 1000 no. of plastic moulded chairs and one row of sofa for VVIPs and 40 no of banquet chair with cover.

Barricading: 3' height bamboo barricade will be made in the two sides of audience sitting area.

Pedestal Fan: 8 no. of Sound less pedestal fan to be placed in the auditorium for audiences

F. LIVE DEMONSTRATION MANDAP

Live Demonstration Mandap will be erected at the different places inside the exhibition ground. On the Mandap some live demonstration activities will be performed by the artisan. The bidder has to quote his lowest possible price for erection each Mandap (Minimum two) as per the specifications mentioned below.

Structure: Bamboo & Cloth Structure, four sides open (a model of Hindu marriage bedi)

Size: 15 'X 15'

Facia: 4' height, flex stretched tightly and fixed with a wooden batten frame on the four side top of the stall, running jhaller placed at the bottom of the fascia.

Flooring: 1 ft. wooden platform with Full floor Durry matting.
