Sealed Tenders on plain paper or letter pad are invited by the undersigned for disposal of one number of vehicle of Tang-Choudwar, Cuttack and now parking at its compound.

1. The envelope carrying the bid must be subscribed in capital letter "OFFER FOR AUCTION SALE OF VEHICLE".
2. The intending tenderers are advised to inspect the above vehicle parked at place mentioned above between 11.00 AM to 4.00 PM from dt.17.10.2019 to dt.24.10.2019 on all working days before submitting the tender. Each tender must accompany an earnest money deposit @ 1% of the offset price only in shape of Bank Draft in favour of the **Tahasildar Tangi-Choudwar, Cuttack payable at Cuttack** which will be refunded to the tenderers whose tenders are not accepted except in case of the successful bidder. The bid price offered shall not be less than the minimum (upset) price as mentioned above in each case.
3. The tender should reach the undersigned by registered post/speed post or by hand on or before dt.24.10.2019 up to 4.00 PM at the latest and tenders received till then shall be opened on the same date at 4.30 PM by the **Tahasildar Tangi-Choudwar, Cuttack** in the presence of the tenderers or their authorized representatives. If this day is declared later as a Government holiday then the tenders will be received and opened on the next working day as per the schedule time. The undersigned will not be held responsible regarding late submission/ receive of tender in any manner.

4. The highest tenderer, whose tender is accepted, shall have to deposit immediately 25% of the offered amount then & there as initial deposit. He shall deposit the balance amount within Seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.
5. The successful bidder shall take permission and remove the vehicle from office campus of **Tahasildar Tangi-Choudwar** Cuttack within seven days of deposit of the bid amount on failure to remove the vehicle within aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
6. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
