
## SEALED TENDER FOR AUCTION SALE OF VEHICLE

1. The envelope carrying the bid must be subscribed in capital letter "OFFER FOR AUCTION SALE OF VEHICLE".
2. The intending bidders are advised to inspect the above said vehicle parked as mentioned above between 11.00 AM to 4.00 PM from Dt. 19.10.2019 to 04.11.2019 on all working days before submitting the tender. Each tender must accompany an earnest money deposit @1% of the upset price only in shape of Bank Draft of State Bank of India in favour of the Tahasildar, Sadar, Cuttack payable at Cuttack which will be refunded to the bidders, whose tenders are not accepted except in case of the successful bidder. The bid price offered shall not be less than the minimum (upset) price as mentioned above in each case.
3. The tender should reach the undersigned by registered post / speed post or by hand on or before 04.11.2019 up to 4.00 PM at the latest and the tenders received shall be opened the same day at 4.30 PM by the Tahasildar, Sadar, Cuttack in presence of the bidders or their authorised representatives. If this day is declared as a Government holiday, then the tenders will be received and opened on the next working day as per the schedule time. The undersigned will not be held responsible regarding late submission / receive of the tender in any manner.
4. The highest bidder, whose tender is accepted, shall deposit immediately 25% of the offered amount then and there as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.
5. The successful bidder shall take permission and remove the vehicle from the office campus of Cuttack Sadar Tahasil within seven days of deposit of the total bid amount. On failure to remove the vehicle within 15 days from the date of deposit of total bid amount, the successful bidder will have no right to claim the auctioned vehicle.
6. The authority reserves the right to reject any or all tenders without assigning any reason thereof.
