The candidates can take help of the reference books (brought by himself) only while answering the question papers. Copying from neighbouring candidate or giving help to other candidates is not allowed and candidate doing so shall be immediately expelled from the Examination Hall.

Again, no candidate shall be allowed to enter the examination hall with any type of electronic gadgets including **mobiles/cell phones** and they must also refrain themselves from talking inside the Examination Hall until the Examination has ended and they are outside the Examination Hall.






