- 4) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of Tahasildar Mahanga payable at Kuanpal.



TERMS AND CONDITIONS FOR HIRING OF VEHICLES.

The following terms and condition must be fulfilled by the successful bidder for providing a vehicle on hire on daily rent basis.

1. The vehicle should not be more than one year old by 30.12.2019.
2. Minimum mileage would be followed according to the guideline of Government.
3. Any type of repair & servicing will be borne by the agency as & when required during the period of hiring.
4. The consumption of HSD/lubricant will be borne by the agency.
5. The vehicle must have valid documents as such as RC Book, up-to-date Road Tax, permit & fitness certificate, insurance certificate, pollution certificate and such other documents required for hiring the vehicle.
6. The vehicle shall be used both inside and outside the district.
7. Only Taxi permitted vehicle will be provided by the agency.
8. Service Tax would be reimbursed over and above the hire charges and TDS will be applicable to the bill.
9. The agency should be registered under appropriate laws/ acts of Government for providing vehicles on daily rent basis.
10. The agency is to ensure reporting and exit time of vehicle and recording of full signature of traveler along with designation in the Log Book of the hired vehicle.
11. The agency is also to record time of entry and exit along with the KM reading in the Log Book.
