Term and Condition

1. The intending tenderers are advised to inspect the above mentioned vehicle during the Office hours from dt.18.02.2020 to dt. 12.03.2020 on working days before submitting the tender. Each tender must accompany an earnest money deposit of Rs.5000/- only in shape of Bank Draft/Demand Draft in favour of the **DWO-cum-DM, OSFDC, Cuttack** payable at Cuttack which will be refunded to the unsuccessful tenderers. The bid price offered shall not be less than the minimum (upset) price as mentioned above.
2. The tenderer has to submit the following documents with the Tender
 - i. Identity Proof (Pan Card, Aadhar Card, Voter ID Card any one)
 - ii. Bank Passbook front page
 - iii. Address Proof
 - iv. Registration Certificate of in case of firm.
3. The tender shall be finalized on the basis of the highest amount quoted by person /firm/agency.
4. The tender should reach the undersigned by registered post/speed post or by courier only on or before dt. 12.03.2020 up to 5.00 PM and the tenders received after the due date shall not be entertain. The tenders shall be opened on the same date at 5.30 PM by the DWO-cum-DM, OSFDC, Cuttack in the presence of the tenderers or their authorized representatives. If that day is declared later on as a Government holiday, then the tenders will be received and opened on the next working day as per the schedule time. The undersigned will not responsible for any postal delay.
5. The envelope carrying the bid must be subscribed in capital letter "**OFFER FOR AUCTION SALE OF VEHICLE**".
6. The highest tenderer, whose tender is accepted, shall have to deposit immediately 25% of the offered amount then & there as initial deposit. He shall deposit the balance amount within Seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the terms within the stipulated time, the deposited amount including the earnest money shall be forfeited. The EMD of successful bidder shall be adjusted at the time of final payment of tender value.

7. The successful bidder shall take permission and remove the vehicle from office campus of Collectorate, Cuttack within seven days of deposit of the bid amount. On failure to remove the vehicle within aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
