1. **Bid Price**

- i. The price shall be inclusive of all duties, taxes and other levies payable by the dealer, including transportation.
- ii. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- iii. The Prices should be quoted in Indian Rupees only.
- iv. After Finalization of tender, supply will be done as per the work order which will be issued at the beginning of each sowing season. No Consolidated Work Order will be issued by OLM, DRDA or any other agency at one time. The Work Orders shall be separate, spread out over the sowing seasons and may be placed by DRDA, Blocks or any other entity, public or private, as directed by DRDA. Delivery will be made as per the work order quantity at the price quoted in this tender. No renegotiation will be allowed at that stage.

2. **Terms and Conditions**

- All seeds in one seasonal kit should be packed separately and bunched together in a waterproof packet for each household.
- The last date for submission of Tender is 15.07.2020 till 11.00 AM
- Tender will be opened on 15.07.2020 at 12.00 Noon in presence of the suppliers or their authorized representatives in the Office of OLM, DRDA Campus, Cuttack.
- Postal and e-mailed Tender are not acceptable.
- The Sealed Tender Should be dropped in the Tender Box Kept in the Office of OLM, DRDA Campus, Cuttack.
- The Bidder should produce sample of the product as per the specification during tender opening time.
- The specifications should be strictly adhered to.
- Sanction of any advance will not be considered.
- Payment will be made subject to timely supply of seeds and submission of delivery receipt duly certified by the Block/GPLF and counter signed by BPM.
- The rate offered by the firm should be valid for one year.
- Quality certificate should be provided by the dealer.
- Any damage caused during transport is the sole responsibility of the Dealer.
- 20% of the Quoted amount should be deposited as security money towards quality assurance for 04 month of supply after selection.
- Tender received late and incomplete will not be considered. The bidder should sign and stamp each page of the Tender document.
- All disputes are subject to the jurisdiction of the courts at Cuttack, Odisha only.
- The authority reserves the right to accept or reject any tender without assigning any reason thereof.
- The bidder shall furnish the following documents to establish the bidder's eligibility.
 - a) Self-Attested photocopies of PAN card
 - b) Self-Attested photocopy of GST Registration Certificate.
 - c) Refundable EMD amounting to Rs. 60,000/- as DD in favour of PROJECT DIRECTOR, DRDA, CUTTACK payable at SBI, Bidyadharpur branch.
 - d) The EMD of L1 shall be refundable after execution of the work. Other EMDs shall be refunded immediately after opening of the Tender.
 - e) Non-refundable amount of Rs. 1000.00 for paper cost in form of DD in favour of PROJECT DIRECTOR, DRDA, CUTTACK payable at SBI, Bidyadharpur branch.
