Sir,

Inviting a reference to the above mobile SMS to Collector, Cuttack on 25.11.2020, I am intimating the following facts as available from this Office record regarding your incumbency as WEO in Cuttack District for your information and necessary action.

You have posted in Cuttack District as WEO in Cuttack Sadar Block for the period from 20.02.2006 to 31.05.2006. You have joined in the block on 20.02.2006 without furnishing the relieve order from the previous station i.e. BDO, Talcher and as per the instruction received from the Govt. in ST/SC Development Deptt. Memo No.20502 dtd.22.05.2006, you have been relieved from Cuttack Sadar Block on 31.05.2006 vide Office Order No.1538 dtd.31.05.2006 of BDO, Cuttack Sadar.

Considering your grievance petitions filed before different District level Officers, a hearing was taken up at 12.30 P.M. on 10.11.2020 in the Office Chamber of ADM (Rev), Cuttack wherein BDO, Cuttack Sadar and District Welfare Officer, Cuttack were present. Despite of several communications, you have not attended the hearing and the hearing was taken up with the concerned Officers. The Block Development Officer, Cuttack Sadar Block has taken expedite action accordingly and has reported the followings.

1. The payment towards salary for the period from 20.02.2006 to 29.05.2006 has been made and paid to you.
2. As regards payment of RCM Bills of Rs.9301/-, BDO, Cuttack Sadar stated that, no such bill is available in his Office & other two RCM bills amounting Rs.859/- and Rs.754/- had been received in his Office on 09.07.2007 i.e. after being relieved from the Office. Hence, those RCM vouchers have been sent to BDO, Rayagada with LPC vide letter No.2281 dtd.18.11.2020.
3. The LPC, Drawal Particulars and Leave application including NDC has been transmitted to the BDO, Rayagada in your next station vide letter No.2281 dtd.18.11.2020. (copy enclosed).

Further, it is to intimate that the admissible dues pending in Cuttack district in respect of your incumbency period have been settled and there is no more due is pending for disbursal.

PROCEEDINGS OF THE HEARING ON GRIEVANCE PETITION OF SRI MANAS RANJAN PATTNAIK, EX. WEO, CUTTACK SADAR HELD ON 10.11.2020 AT 12.30 P.M. IN THE OFFICE CHAMBER OF ADM, CUTTACK

The hearing on grievance petitions of Sri Manas Ranjan Pattnaik, Ex. WEO, Cuttack Sadar Block was taken up on 10.11.2020 at 12.30 P.M. for settlement of his pending service benefits during his incumbency in Cuttack District. The District Welfare Officer, Cuttack was present in the hearing. The Block Development Officer Cuttack Sadar appeared the hearing with relevant documents whereas, Sri Manas Ranjan Pattnaik, Ex WEO the Petitioner did not attend the hearing inspite of several messages through SMS over phone/Registered Post/phone calls to attend the hearing on 10.11.2020.

All the petitions of Sri Pattnaik were examined thoroughly. The claims made by Sri Pattnaik through his petitions to Collector, Cuttack/ DWO, Cuttack are as follows:

1. In the grievance petition dtd.14.08.2015, it is claimed by him that his working tenure in Cuttack District was from 20.02.2006 to 26.02.2009 and his long standing claims etc. are pending in the Office of BDO, Cuttack Sadar Block, Sub-Collector, Cuttack Sadar & DWO, Collectorate, Cuttack during the period.

But BDO, Cuttack Sadar apprised that Sri Pattnaik was working in Cuttack Sadar from 20.02.2006 to 31.05.2006. Sri Pattnaik had joined in Cuttack Sadar Block on 20.02.2006 and relieved from duty on 31.05.2006 which was communicated vide Order No.1538 dtd.31.05.2006 of BDO, Cuttack Sadar. Further, it is also a fact that there is no such post of WEO in the Office of the Sub-Collector, Sadar Cuttack and DWO, Collectorate, Cuttack as the petitioner claimed that he was working in those Offices.

2. Sri Pattnaik further claimed for payment of salary for the period from (1) 30.05.2006 to 31.05.2006, (2) 01.06.2006 to 23.06.2006, (3) 24.06.2006 to 18.07.2006 (4) 19.07.2006 to 03.10.2008 (5) 04.10.2008 to 20.02.2009, (6) 21.02.2009 to 26.02.2009.

On verification of relevant records produced by BDO, Sadar Cuttack, it is found that he has been paid salary from 20.02.2006 to 29.05.2006 in initial pay as his Original Service Book and LPC had not been received from his previous station. Salary for 30.5.2006 and 31.05.2006 has not been paid to him.

BDO, Cuttack Sadar was directed to enquire into the reason for non-payment of salary for the above mentioned two days and if the petitioner had worked during those days, the salary for the two days be drawn and disbursed to him through A/C Payee Cheque to be sent by Regd. Post. Secondly, BDO, Sadar stated that as he had been relieved from Sadar Block on 31.05.2006, salary for other period as claimed by him cannot be entertained.

3. Sri Pattnaik has claimed for payment of RCM of Rs.9,301/- submitted on 24.04.2006, Rs.859/- submitted on 24.04.2007 and Rs.754/- submitted on 09.07.2007 (Total Rs.10,014/-).

In this context, BDO, Cuttack Sadar was directed to verify the RCM bills/Vouchers submitted by Sri Pattnaik and the claims be paid as admissible.

4. Similarly, Sri Pattnaik has claimed that, his TE & TTE are pending with BDO, Sadar from March 2006 to December 2006 according to his tour particulars.

BDO, Cuttack Sadar was directed to verify the approved tour particulars pending at his level if any and make payment to him within a week if permissible.

5. Sri Pattnaik claimed for HRA payment from March 2006 till 2009.

BDO, Cuttack Sadar stated that, as he was in occupation of Govt. Quarter since his joining, his claim for HRA is not genuine.

6. Sri Pattnaik has also claimed for quarter repairing expenses of Rs.3,200/- incurred by him on 31.03.2006.


In this respect BDO Sadar submitted that, as the quarter repairing work is vested with R & B Department, the personal expenditure incurred on repair of quarter cannot be considered as per Rule.

7. It is claimed by Sri Pattnaik to update all admissible service benefits of Pay, Grade Pay, DP, DA, HRA, EB, TBA, Annual normal increments, Additional enhanced DA etc as per ORSP Rules, 2008 w.e.f.20.02.2006 to 26.02.2009 and differential amount of pay, grade pay, DA, DP, additional enhanced DA, HRA etc which has been drawn in the initial Pay of Pre-revised scale w.e.f. 20.02.2006.


BDO, Cuttack Sadar stated that, as the Original Service Book of Sri M.R. Pattnaik has not yet been received from his previous station, it is not possible to draw any differential arrear pay etc.

However, BDO, Cuttack Sadar Block was directed to transmit the Last Pay Certificate and No Dues Certificate of Sri Manas Ranjan Pattnaik, Ex. WEO to his next Service Station after drawal of the admissible claims within fifteen (15) days without waiting for his Original Service Book.

Accordingly, the representation of the petitioner was disposed of.
