

TENDER CALL NOTICE FOR DISPOSAL OF UNSERVICEABLE 108 AMBULANCES IN CUTTACK DISTRICT

1. Sealed Tenders are invited in prescribed format from the intending bidders for disposal of 43 numbers of unserviceable 108 ambulance **“AS IS WHERE IS BASIS”** along with outstanding tax liabilities if any.
2. Starting date of Tender- **01.09.2021**
3. Last date & Time of Receipt of Tender- **15.09.2021 up to 5 PM**
4. Date of Opening of Tender-**16.09.2021 at 11.30 AM**
5. Cost of Tender paper- Rs.500/- in shape of Bank Draft in favour of **“ZSS MISCELLANEOUS, CUTTACK”** payable at Cuttack.
6. Cost of E.M.D - Rs.3,000/- **per vehicle** in shape of Bank Draft in favour of **“ZSS MISCELLANEOUS, CUTTACK”** payable at Cuttack

8. The tender will be super scribed as **“Tender for Disposal of unserviceable 108 Ambulance in Cuttack District.”**
9. The bidder must attach photocopy of IT Return for the A.Y – 2020-21 and GST Return for the month of July’2021 along with the bid.



GENERAL TERMS AND CONDITIONS

1. The Vehicle put to tender will be disposed off “**AS IS WHERE IS BASIS**” along with outstanding tax liabilities if any.
2. The intending bidders may inspect the vehicles in the premises of different institutions where it is parked with permission of concerned authority within office hours.
3. The intending bidders shall have to deposit tender paper cost @Rs.500/- in shape of bank draft in any nationalized bank in favour of “**ZSS MISCELLANEOUS, CUTTACK**” separately for each bid. Tender paper without deposit of tender paper cost will not be considered.
4. The intending bidders shall have to deposit earnest money @Rs.3,000/- per vehicle in shape of bank draft in any nationalized bank in favour of “**ZSS MISCELLANEOUS, CUTTACK**”. The bidder may submit the EMD in consolidated manner for the all the vehicles quoted in the bid. Tender paper without deposit of adequate earnest money will not be considered.
5. Bid documents without EMD and tender paper cost will be summarily rejected. EMD of unsuccessful bidders will be returned without interest after finalization of tender. EMD of successful bidder will be retained as Security Deposit & will be refunded without interest only after the successful removal of the vehicle against deposit of full amount as finalised in the auction along with GST and other dues if any. The successful bidder should submit the certificate from the concerned authority where the vehicle is parked regarding successful removal of vehicle with photograph of vehicle. The security deposit is liable to be forfeited if bidder violates or fails to comply with the terms and conditions of the tender.
6. The bidders, quoting highest price subject to above the price fixed by the authority, shall deposit 25% of the offered amount with the “**ZSS MISCELLANEOUS, CUTTACK**” immediately on confirmation of the acceptance of the tender by the CDM&PHO Cuttack in shape of Demand Draft and the rest amount should be deposited within 7 days of above date of submission. On failure of the timely payment of the amount as aforesaid, the vehicle including the earnest money shall be forfeited and the vehicle will be put to fresh tender.
7. The tender will be opened on scheduled date and time in the office chamber of the undersigned in the presence of bidders or their authorized representatives. In the event of the date being declared as holiday for Govt. of Odisha, the due date of submission of bids and opening of bids will be next working day.
8. The tender will be received through Regd. Post / Speed Post / Courier only. Any tender received after the due date & time will be rejected and returned to bidder unopened.



9. The vehicle will be handed over to the successful bidders after making full payment of the accepted tender money.
10. The CDM & PHO, Cuttack will have no liability regarding transportation, loading, unloading or any other incidental charges (if any) with regard to ambulances under auction.
11. The tools and spare parts etc. will not be delivered along with the vehicle.
12. The bidder should furnish Photo copy of IT Return for the A.Y – 2020-21 and GST Return for the month of July 2021 along with the bid.
13. The bidder shall remove the vehicle from the site within 07 days of confirmation letter from the undersigned. The bidder shall have the responsibility to removal of branding out of ambulance before shifting from the parking location. It will be the responsibility of the bidders to ensure safety of the auctioned vehicle and no claim or complain will be entertained for any misshapen to the vehicle once it is auctioned.
14. In case the bidder whose tender is accepted, fails to remove the vehicle from the office campus within stipulated time he/she shall pay ground rent @1% of his quoted price per day. If the ground rent so charged exceeds the amount deposited by the highest bidder the bidder shall cease to have any right on the vehicle and the amount deposited by the bidder shall be adjusted towards ground rent and the vehicle shall be absolute property of the undersigned.
15. The prices offered by the bidder even though highest, will be rejected if lower than the off-set price fixed.
16. All documents submitted must be signed by the authorised signatory of the organisation with seal.
17. The bidder should present in the tender opening personally or through authorised representative with due authorisation letter otherwise bid will not be accepted.
18. If there is any contradiction between price quoted in figure and word then price quoted in word shall prevail over price quoted in figure.
19. The CDM&PHO, Cuttack in charge of the above vehicle reserves the right of rejecting any of the tenders without assigning any reason thereof.
20. All the correspondence on the tender and disposal of the vehicle is to be made with the CDM& PHO, Cuttack. In case of any dispute or any matter regarding interpretation, the decision of the authority shall be final and binding. Legal proceedings if any shall be subject to the Cuttack jurisdiction only.
