**Provisional notification showing division of Wards and Reservation of Seats in the
Banki Notified Area Council
NOTIFICATION**

Whereas, the draft notification bearing No.07, dated the 03rd January, 2022 was published in Form-XXI of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 inviting objections and suggestions from all persons interested in respect of the said draft notification showing the division of the area of the Banki Municipal Council/ Notified Area Council into Wards and reservation of seats thereof on or before the date of expiry of the period of ten days;

And whereas, objections and suggestions received within the period so specified have been duly considered;

Now, therefore, in exercise of the powers conferred by Sub-section(3) of Section 12 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950), the District Magistrate, Cuttack do hereby divide the area of the said Banki Municipal Council/ Notified Area Council into **17** Wards as specified in Column (2) of the Statement-I below with the description and boundaries of the said wards against each in Column (3) and (4) respectively thereof for the purpose of ensuing election of Councillors to the same and determine the Wards as specified in Column (2) of the Statement-II below in which the seats reserved under Section 11 of the said Act shall be set assigned against each in Column (3) thereof.

Any persons aggrieved by the order passed by the District Magistrate under Sub-rule (4) of Rule 2-A may file and appeal before the State Government under the second proviso to Sub-section (3) of Section 12.
