NOTIFICATION

Whereas it has come to the notice of the undersigned that due to plying of large number of Heavy vehicles (Hyva/ Trucks) loaded with sand & other materials through the Kathajodi River embankment (Right) OAE No.94(B) from Jhinkiria to Berhampur in 42 Mouza and OAE No.95(B) on Surua river left embankment in 42 Mouza , people in general and villagers of 42 Mouza areas in particular are not only facing difficulties to use the Road for communication, but also precious lives of people using the road are lost. Besides, the plying of Heavy vehicles with overload of sand posing threat of damage to the Kathajodi river embankment, which has not been designed to sustain the load of heavy vehicles. The 42 Mouza road also become a death trap due to irregular plying of such vehicles.

Now, therefore, I Sri Bhabani Shankar Chayani, OAS(SAG), , Collector & Dist. Magistrate-cum-Chairman, RTA, Cuttack being satisfied that it is necessary in the interest of safety/longevity of above embankments as well as in the interest of safety and convenience of villagers of 42 Mouza to restrict movement of Heavy commercial vehicles (Hyva/Trucks) on the above-mentioned Road, in exercise of powers conferred on me U/s. 115 of MV Act, 1988 read with Rule-173 of Orissa Motor Vehicles Rules, 1993, do hereby restrict :

1. Movement of Heavy commercial vehicles (Trucks) having more than 6 Wheels (Gross weight of 16,200 Kgs and above) and heavy vehicles carrying sand and other materials, on the Road Kathajodi river embankment (Right) OAE No.94(B) from Jhinkiria to Berhampur in 42 Mouza and OAE No.95(B) on Surua river left embankment in 42 Mouza. (FROM 6.00 A.M. TO 10.00 P.M. WITH THE RELAXATION FROM 10.00 P.M. TO 5.30 A.M.),
2. The restriction, however, will not be applicable to Heavy commercial vehicles to be used for essential services and for construction and repair of the road in the locality and nearby villages of 42 Mouza areas.
3. It is further ordered that in exigencies of public service and if situation warrants to ply such vehicles, the concerned vehicle owners/firms/organizations will have to obtain prior permission from the concerned Collector & District Magistrate/Dy. Commissioner of Police for plying of heavy commercial vehicles.

THESE RESTRICTIONS WILL COME INTO FORCE FROM 06.00 A.M. TO 10.00 P.M. ON EVERY DAY FROM 18TH. APRIL, 2022 TILL 17TH. MAY, 2022.
