**SOP for DWOs to undertake Awareness and Sensitization Programmes
on "Protection of Civil Rights Act and Rules, SC & ST (Prevention of Atrocities) Act
and POA Rules and Prevention of Witch Hunting Acts" .**

1. Awareness and Sensitization Programmes at block levels /P.S level of 16 Atrocities prone districts and some sensitive Police Stations area on "Protection of Civil Rights Act and Rules, SC & ST (Prevention of Atrocities) Act and POA Rules and Prevention of Witch Hunting Act" during the month of July-August,2022
2. This programme aimed to create Awareness among the general public, Peoples Representatives, Tribal Youth, Govt. Officials, Legal Practitioners, Social Activists and Media persons and to sensitize them on salient provisions of PCR & POA Act and Rules. The number of participants shall be at least 50 for each programme
3. DWOs are requested to engage some registered and eligible Non-Government Organizations / Institutions /Community based Organisations(CBO) of Odisha to undertake a number of These awareness programmes in the sensitive blocks / Police Stations of Angul, Bhadrak, Boudh, Balasore, Cuttack, Dhenkanal, Deogarh, Kandhmal , Kalahandi, Kendrapada, Khurda, Keonjhar, Mayurbhanj, Nuapada, Puri , Sonapur and Sundargarh atrocity prone districts.
4. The method of selection of NGO is either through open invitation or depends upon the convenience of DWOs. He/She should have selected such NGOs who have already organized such sensitization and awareness programmes in their blocks earlier sponsored by ST & SC Development Department & SCSTRTI shall be given preference.
5. These programmes are to be organized by the selected NGOs those are working for the protection against exploitation of SCs & STs & Rights and Welfare of those vulnerable populations inhabiting in Atrocity and Witch Hunting Prone areas of the state.
6. The List selected blocks and Police Stations are given in table below for organization of the awareness Generation programme.


7. A total number of 100 Blocks and P.S of 17 districts have been proposed to be covered as detailed above in Para-6.
8. Duration of each programme shall be one-day. Date shall be fixed on any working day in the month of July--August,2022 with a prior intimation to SCSTRTI.
9. DWOs to Selected NGOs/CBOs and allot blocks/ Police Stations to accomplish the sensitization & awareness programmes on scheduled dates & time with a prior intimation to Advisor-cum-Director & Spl. Secy., SCSTRTI. He/she has to facilitate in selection and invitation of participants, pre-fixed dates. DWO may either present or depute his/her departmental officer to be physically present in the venue and report about the satisfactory accomplishment of the awareness programme on scheduled dates and time.
10. Fund to the tune of Rs. 25,000/- only(Rupees Twenty-Five Thousand only) per block level /Policestation Level programme is earmarked to be spent and the NGOs may be requested to display at least a number of IEC materials and undertake sensitization and awareness activities like, *Pala, Dasakathia*, street Play, folk/traditional performing arts depicting messages of "Protection of Civil Rights Act and Rules, SC & ST (Prevention of Atrocities) Act and POA Rules and Prevention of Witch Hunting Act".
11. SCSTRTI will place fund to DWOs on the basis of number of block level/P.S Level programmes scheduled to be held with reference to Para -6 above i.e @Rs.25, 000/- only per prog. during the month of June, 2022
12. Payment to NGOs shall be made by concerned DWOs after the completion of one each programme. NGOs claim for payment must have to submit the bills, photographs, proceedings and list of participants, list of Resource Persons, types of Activities undertaken, news clips, Video

Clips, and other supportive documents in hard and soft form which need to be forwarded to the Advisor-cum-Director & Spl.Secy. , SCSTRTI along with the UC & Work Done Certificate issued by the concerned DWOs. It is suggested for payment to NGOs within the seven working days after production of bills/ vouchers and all desired documents.

13. The target date of completion of all these awareness programme is 31.08.2022

14. DWOs are requested to send the detailed list of the NGOs entrusted with block level /Police Station level awareness activities as per the format given along with the UC, Work done Certificates ,types of activities undertaken, ,Photographs, Video clips, News clips, proceedings, List of participants , list of Resource Persons, copy of IEC materials displayed and soft copy of all these supportive documents .
