Terms & Conditions:

01. The details of work including the Tender paper, E.M.D. required, Class of Contractor, Completion of time, Cost of Tender Paper etc are available in the website 'http\www.cuttack.nic.in' from 14.10.22 to 31.10.22. You are requested to collect tender papers from the said office and fill up the same and submitted to the office of the B.D.O, Cuttack Sadar along with all required/requisite documents.
02. The Cost of tender paper in shape of Bank Draft/Bankers cheque (drawn in any Nationalized Bank in favour of B.D O CUTTACK SADAR. Payable at State Bank of India, CUTTACK SADAR should be enclosed with the tender document in separate envelope mentioning cost of tender paper.
03. Sealed tender complete shape will be received from 14.10.22 to 31.10.22 up to 1.00PM in the office of the Panchayat Samiti, CUTTACK SADAR through Registered Post/ Speed Post the tender document may be dropped in the Tender Box Kept in the Cash Section of BDO, Cuttack Sadar. No documents in respect of the said Tender shall be entertained beyond the schedule date and time mentioned in the notice.
04. The tender shall be opened on 31.10.22 at 3 PM onwards in the office chamber of the B.D.O, CUTTACK SADAR in presence of the Bidders or their authorized representatives having written authorization for the purpose.
05. The authority reserves the right to accept/ reject/ cancel all the tender papers without assigning any reason thereof.
07. Other term & conditions are available in DTCN.
08. The following documents should be furnished with the Tender papers failing which the tender is liable for rejection:
 - i) Cost of Tender Paper in shape of Bank Draft in favour of B.D.O, CUTTACK SADAR.
 - ii) Earnest Money Deposit declaration should be submitted as per prescribed proforma
 - iii) Attested copy of Contractor Registration Certificate
 - iv) Attested copy of PAN Card / GST Registration Certificate and Clearance certificate for the year 2022-2023.
 - v) The bidders have to produce an affidavit in support of the authenticity of documents with the tender paper/ Norelation certificate / Acceptance of Tender conditions/ free from Criminal proceeding etc
 - vi) Contractor registration Certificate, Valid Labour License.
 - vii) Letter of submission of Tender
 - viii) Bill of Quantity duly filled in and signed in each page of tender.
 - ix) Any other relevant document if any.
 - x) Bids completed in all respect accompanied with the documents in sealed cover should be submitted to the Tender inviting authority in the office address of BDO, Cuttack Sadar through Registered post/Speed Post /or the tender document may be dropped in the Tender Box Kept in the Cash Section of BDO, Cuttack Sadar. No documents in respect of the said Tender shall be entertained beyond the schedule date and time mentioned in the notice.

09. Regarding Bid Security (EMD) : As per Finance Department, Govt. of Odisha No. 8943 Dtd-18.03.2021, due to Covid-19 pandemic , no provision regarding Bid Security should be kept in the Bid Documents and only provision for " Bid security Declaration" should be kept. The bidders should execute a Bid Security Declaration in lieu of Bid security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents. Only successful bidder is to provide the Bid Security/ EMD before signing the Agreement...
10. Successful bidder shall be deposited the performance security in shape Demand Draft/ Banker's Cheque of any nationalized bank in favour of B.D.O,CUTTACK SADAR at the time of agreement
- (i) Below 5% - no APS
- (ii). Above 5 % and below 10 %, the bidder deposit the 50 % difference amount between tender value and quoted value.
- (iii) From 10 % and above, the bidder requires to deposit 150 % of difference amount between tender value and quoted value as per office memorandum No.4559/W, Dtd. 05.04. 2021 of Commissioner-cum-Secretary to Govt. Works Deptt. Odisha.
- Any other forms of performance security will not be accepted. No exemption for deposit of APSD @ 50% to SC/ST Contractor.

11. As per the OPWD Manual, A price preference upto 10% may be allowed in favour of individual SC/ST contractors. Such price preference shall be given for an individual SC/ST contractors. Those SC/ST contractors desires for availing price preference should submit an affidavit in support of caste certificate and attested copy of caste certificate issued by the competent authority, otherwise their tender will be liable for rejection.

12. Engineering Contractors or ST&SC contractors those availed the Govt. facilities for execution of contract should submit an affidavit with the Tender Documents that they should not sublet the work to any other contractor or person, otherwise their tender will be liable for rejection. If the successful contractor allowed to subletting the work to other contractor or person, they should be penalized and blacklisted.

13. If the date of opening of the tender as specified above happens to be holidays, then the process of opening will be shifted to immediate next working day at the same specified time and venue respectively without further notice.
14. The EMD & Additional Performance Security Deposit of the Successful Contractor are to be forfeited if the tenderer back out from the offer of acceptance of tender by the competent authority and also intimated to the License Issuing Authority for taking necessary action against them.
15. Shortfall of any required documents, the tender paper is liable for rejection.
16. Since the works are time bound programme, the tenderers have to complete the work within the stipulated time period of completion. Those who are unable to complete the work within the time, up to 10% penalty will be imposed on the whole amount.
17. One Registered Cover should contain Tender Papers for One Work Only. If tender papers for more than one work are found in a Single Registered Cover, then all the tender documents will be rejected.
18. The successful bidder has to produce his Original Documents (License, PAN Card / GST clearance certificate/Caste Certificate/ Engineering Contractor License etc) at the time of Agreement for verification.
19. Successful Tenderer will have to submit their work programme for timely completion of the work within the stipulation of period of completion at the time of agreement.
20. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
