**SHORT TENDER CALL NOTICE**

The Tender Call Notice issued vide this Office letter No. 11692/Niz dated 08.11.2022 is extended to 19.11.2022 at 4.00 p.m. Hence, sealed quotations/ tenders are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing of 3 (three) nos. of Indigo diesel / Swift Dzire (Diesel or Petrol) driven vehicle, which shall conform to the Terms and conditions (Annexure-II) for official use of Additional Commissioners, Consolidation & Settlement in Kendrapara, Bhadrak & Nayagarh District on monthly rent basis.

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee bank Draft drawn in favour of the **AFA-cum-Under Secretary to R.D.C., (C.D), Cuttack** or may deposit in shape of cash in this Office and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge shall be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The Vehicle must achieve a fuel efficiency of **17** Kms. Per litre for Indigo and for Swift Dezire (Diesel & Petrol) respectively.
- 7) The details of the make and year of manufacture of the vehicle, registration no, mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-III).


