



TERMS & CONDITIONS

1. The bidder should be having a valid GST registration certificate under Govt. of Odisha and should upto date PAN and VAT clearance certificate.
2. The bidder has to submit valid authorization certificates from the Manufacturer/Dealer/Distributor for the items quoted. The bidder should produce proof of successful execution of similar nature of works.
3. The supplier shall depute experienced persons for installation, commissioning and testing of equipment supplied.
4. If the material/equipments for any portion thereof damaged or lost during the transit and installation, the vendor shall effect the replacement of such material/equipments within a reasonable time to valid delay in commissioning the equipments.
5. The quotaion shall be valid for 180days only. Any offer falling short of the validity period is liable for rejection.
6. The rates quoted in quotation must be inclusive of all taxes and other charges.
7. The authority reserves the right to remove old and new items as per requirement during installation.
8. The quotations received after due date will not be entertained.
9. Income tax returns of the vendor/firms for last 3(three)years.
10. Cost of installation/transportation to the market yards i.e. 2(two) locations as mentioned above/lifting and training to the employees will be borne by the supplier.
