**INVITATION FOR BIDS (IFB)**  
**'e' PROCUREMENT NOTICE NO. - 01/2023-24**

The Block Development Officer, Niali Cuttack on behalf of Hon'ble Governor of Odisha invites online percentage rate basis tender for the work in D.T.C.N through e-procurement for execution of the works mentioned below. The bid should be submitted on-line in the Government website [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) by eligible class of contractors as mentioned below registered with State Government & contractors of equivalent grade/ class registered with Central Government/ MES/ Railway to be eventually drawn in P-1 form. The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Govt. within a month of acceptance of bid. The bidders registered outside the State are required to submit an under taking in the form of an affidavit, that they are not registered under the GST act in the State of Odisha as they have not started any business in the State and they have no liabilities under the Act. But bidder has to produce copy of GSTIN certificate before signing of agreement. For bidders registered within the State, no tender would be considered without a valid GSTIN certificate.

1. **Mode of Submission of EMD/Bid Cost** : The bidder shall transfer the required amount of EMD/Bid Cost On-line as mentioned for the specified work in Column 4 & 5 respectively in the above table through a process as mentioned in DTCN.
2. **Mode of submission of tender** : Tender should be submitted on-line in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) each set of bid document and Bill of Quantity in MS Excel format.

4. Any addendum / corrigendum / cancellation of above tender will be published in the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in), and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish, can modify their tenders.
5. Bid document consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the works are available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale. Interested tenderers may obtain further information at the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in).
6. The bid for the work shall remain open for acceptance for a period of 90 days from the last date of receipt of bids. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
7. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission.
8. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card and Bid security declaration etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all. Labour license is to be produced by the successful bidder at the time of agreement.
9. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection of all such tender papers of the concerned bidder.
10. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on the merits of rest of bids. But if more than one bid is quoted at 14.99%(decimals up to two numbers will be taken for all practical purposes) less than the tendered amount, the tender will be finalized through a **transparent lottery system which will be held** in presence of all bidders/their authorized representatives (if they wish so), the Block Development Officer, AEE, AO and CP . Hence all the bidders can enquire in the office of the undersigned regarding lottery before the scheduled date as no further correspondence to the bidders in this regard will be made.
11. If L1 bidder does not turn up for agreement after finalization of the tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor. In that case, the L2 bidder, if fulfills other required criteria will be called for drawing agreement for execution of the work subject to the condition that the L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise the tender will be cancelled.
12. Block Development Officer, Niali Cuttack shall not be responsible for any postal delay and / or non receipt of the original copy of bid security and bid cost on or before specified date and time. Non submission of

cost of Bid and Bid security declaration within the designated period shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked.

13. The Original documents along with a set of its Xerox copies against the scanned copy of R.C. (Registration certificate), GSTIN, PAN, Affidavit and other requisite documents submitted through web-site should be produced in the O/O Block Development Officer Niali, Cuttack for verification on demand after opening of the Technical Bid.
14. The Schedule Caste/ Schedule Tribe/ Physically handicapped Contractors desirous to avail the facility of preference as per Works Department should produce their original registration certificate stating the fact of Caste/ Physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.
15. Engineer contractor desirous to avail the exemption of EMD is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to whom the tenders have been submitted, must be mentioned in the affidavit & he should produce his original registration certificate at the time of opening of tender failing which the tender will be rejected.
16. The Additional Performance Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential i.e. estimated cost put to tender minus the quoted amount as Additional performance security (APS) in shape of Term Deposit Receipt pledged in favour of the Block Development Officer, Niali Cuttack / Bank Guarantee in favour Block Development Officer, Niali Cuttack from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Niali within seven days of issue of Letter of Acceptance (LoA) by the Block Development Officer Niali, Cuttack (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. (As per Works Department Office Memorandum No.14459/W, Dated 20.09.2018).

The State Government is in receipt of many representation that on account of slowdown in economy due to pandemic COVID-19, there is acute financial crunch among many contractors, which in turn is affecting timely execution of the contracts. It has also been represented that this may affect the ability of the contractors to bid in tenders and hence reduce competition. Request is being received in quantum of Additional Performance Security in the Government contracts. In view of the above, the state Government is pleased to fix the rate of Additional Performance Security as per Works Department Office Memorandum No.4559/W, Dated 05.04.2021.



18. Any addendum/corrigendum/cancellation of the above tender will be published in the web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) and in the notice board. The system shall generate a mail to those bidders who have already uploaded their tenders and those bidders if they wish can modify their tenders.
19. The authority will not be responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
20. The On-line bidder shall digitally sign on all statements, documents, certificates uploaded by him owning responsibility for their correctness/authenticity as per IT ACT 2000. If any of the information is found to be false/fabricated/bogus, his/her EMD/Bid Cost shall stand forfeited and his/her registration in the portal shall be blocked and bidder is liable to be blacklisted. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof. No tenderer can demand the cause of rejection of his offer.






