The auction sale will be held subject to the following conditions:-

1. That, the bidder shall be a bonafide Holder of Molasses Licence of the State of Odisha.
2. That, the Molasses will be sold on "AS IS WHERE IS" basis.
3. That, the bids will be in terms of per MT of Molasses.
4. That, the reserve price of Molasses is fixed Rs. 12,000/- per MT.
5. That, the intending bidder shall have to submit the following documents before the Officer conducting auction to take part in the auction sale:-
 - (a)Application in the Prescribed Form duly filled in(**Annexure-A**)
 - (b)Copy of Molasses Licence issued by the Excise Department,Odisha(Self Attested)
 - (c)Account Payee Bank Draft of Rs.1000/- towards Security Deposit drawn in favour of the Superintendent of Excise, Cuttack.
 - (d)Copy of Aadhaar Card,PAN Card(Self Attested)
 - (e)Colour Passport Photo(Self signed in frontage)
6. The authority conducting auction shall have rights to conduct action sale for the entire or part quantity of Molasses.
7. That, the bid provisionally accepted by the officer conducting the auction, is subject to confirmation of the higher authority.
8. That, the amount knocked down in favour of the successful purchaser shall be deposited by him/her in the treasury through treasury Challan under proper head of account in IMFS Portal "0039-00-150-0049-01011-000 - Fines and Confiscation (Fines and Forfeitures)" soon after the confirmation of the same by the higher authority, after adjustment of the security deposit. If he/she fails to make such payments, the security amount will be forfeited to the State and the seized Molasses shall be put to fresh auction sale again on such future date(s) as notified thereafter and the defaulting purchaser will be debarred from bidding again. Besides, the security amount will be refunded to unsuccessful bidders soon after confirmation of the bid by the higher authority.
9. That, the successful bidder shall remove of the quantity of auctioned Molasses from the place of storage(Excise Malkhana) to the authorized godown of the successful bidder on payment of **requisite Transport fee, Import fee,Utilisation Fee,Pass Fee as provided under Rule and issue of Transport/Import Pass** by the Excise Authority as early as possible.
10. The cost of transportation shall be borne by the successful bidder
11. That the successful purchaser shall abide by the provisions of the Odisha Excise Act 2008 and Odisha Excise Rules 2017, Orders and Notifications made there under as applicable from time to time.
