PROCEEDING OF THE DISTRICT ROAD SAFETY COMMITTEE, CUTTACK HELD ON 31.05.2023 BY 4.00 PM AT SADBHABANA SABHAGRUHA, COLLECTORATE, CUTTACK

The Dist. Road Safety Committee meeting, Cuttack was held on 31.05.2023 at the Sadbhabana Sabha Gruha, Collectorate, Cuttack. Collector & Dist. Magistrate & Chairman DRSC presided over the Meeting. Along with other members of the committee, the meeting was also attended by Sri Sibo Toppo, Addl. District Magistrate (Gen.), Cuttack.

The members present in the Meeting is placed as ANNEXURE-A.

Sri S.K. Behera, RTO, Cuttack and co-convener of the meeting welcomed Chairman-cum-Collector & District Magistrate, and all the members present in the meeting. With permission from the Chairman, RTO read-out the Agenda items of the meeting.

Addressing the committee, Collector & Dist. Magistrate, Cuttack emphasized on conducting enforcement drive with regard to road congestion and at the vulnerable points on the roads where accidents are being caused regularly. Observing non-attendance of Officers of road owning and other departments, Collector expressed his displeasure and stressed upon the presence of the Members of the committee from next meeting onwards. Road Safety is an important task for all of the member. Their physical presence and participation can only have concrete strategy to check road accidents and casualties thereby. They are not supposed to depute their Junior officers to attend the meeting. Hence Collector & District Magistrate requested all concerned members to attend the meeting by themselves only from next meeting.

Sri Sibo Toppo, Addl. District Magistrate (General), Cuttack in his address also underscored the need for reduction of accidents and advised all the members of the committee to work sincerely on this important subject which has now become a major issue since Cuttack district is loosing more than 30 lives in a month in road accidents which is considerably very high.

After detailed threadbare discussion, the following decisions were taken:

 Collector asked RTO to send a letter to the defaulting officials who did not attend the meeting under the signature of Collector & Dist. Magistrate-cum-Chairman, DRSC, Cuttack.

(Action: RTO/All Members who were absent in the meeting)

2. Since Manguli Junction is a Black spot and many accidents are being caused regularly, it was directed earlier to close the median permanently with opening for pedestrian under the over bridge. But no action has been taken so far. As such NHAI & SJEPL (Mapple Highways) authority are required to block the medians for minimum 500 Metres in both sides from Manguli chhak and develop one Traffic junction for pedestrian under the over bridge with all signages and signals like Zebra crossing mark, Solar blinkers, Junction Board, Low height barriers, etc.

(Action: NHAI, Bhubaneswar & SJEPL)

3. Steps shall be taken to begin special enforcement drive against illegal parking of heavy vehicles on NH-16 with the support of DCP, Cuttack, SP Cuttack, Rural involving officials of RTO and NHAI. Similarly, a detailed report of encroachment of shops, tea stalls, hotels with place / location to be submitted by SJEPL within a week for taking further action for eviction. However NHAI and SJEPL authorities shall take immediate steps for starting the eviction process as early as possible.

(Action: DCP/SP Rural, Cuttack RTO / SJEPL)

4. Steps will be taken by SJEPL to close the illegal cuts in the medians on the NH-16 and on the other roads with the support of SP, Cuttack. For which, SJEPL authorities will request SP, Cuttack for the staffs and complete the work on priority basis.

(Action: SP, Cuttack/SJEPL)

5. Discussing on the deposition of sands, soils on bridges and roads, it was decided that a letter shall be sent to all the Tahsildars of the districts to issue instructions to sand sairat holders to ensure that the tarpaulin to be covered on the empty dala of the Heavy goods vehicles to restrict leakage of sands. Similarly the sand to be loaded below the dala height and it has to be covered completely by the tarpaulin at the top.

(Action: RTO / All Tahsildars)

 All the road owning departments will install solar blinkers and retro reflective bars at all the median cuts of the road coming under their jurisdiction. SJEPL shall apprise the compliances to the Committee in the next meeting with respect to NH-16.

(Action : All the road owning departments/ SJEPL)

7. Regarding frequent occurrence of accidents at VUP, Urali it is decided that MVI, Cuttack shall visit the location and ascertain the causes of accidents and submit the report to RTO to enable him to take suitable steps to minimize the accidents.

(Action: RTO/ MVI, Cuttack)

8. Collector suggested that a dedicated WEBSITE in the name of "District Road safety society, Cuttack "shall be launched where public, NGO's and all other stake holders shall upload / inform the road safety issues pertaining to Cuttack District. RTO shall take the responsibility of creation of the Website and its launching.

(Action: RTO)

9. Expressing concern by most of the members of the committee on the digging of roads, laying of cable work, renovation of canals, etc., it was decided that road owning authorities responsible for those works must erect cautionary Boards and obstruct the place permanently from Traffic movement to avoid any sort of contowards situation and accidents. They shall sensitize on those issues to the local public prior to starting of the work.

(Action: All the road owning departments)

10. Steps to be taken by the NHAI authorities to install the height barrier at the beginning of the Kathajodi bridge from Bhubaneswar side and at the beginning of the Mahanadi bridge from Balasore side to restrict entry of over height Heavy vehicles from hitting to the height gauge of Railway track and causing traffic jam.

(Action: NHAI / SJEPL)

11. The committee requested RTO to remind defaulting road owning departments through letter to submit the compliance report on Third party audit of road signages and pavement marking on the roads.

(Action: SE, R&B Zivn.II/SE,Charbatia R&B Divn,Choudwar/ EE, R&B Division, Jagatsinghpur)

12.RTO intimated the committee that one NGO, Odisha Calling Foundation, working on road safety having its branch office at Cuttack has applied to work under NGO forum Cuttack. As per report of RTO, the NGO, Odisha Calling Foundation is an active NGO who is working on different road safety activities under STA and RTO, Bhubaneswar II since last 9 Years. As such the NGO, Odisha Calling Foundation shall work under NGO Forum Cuttack.

(Action: RTO)

13. Police-station wise accidents report of the District from January, 2023 to April, 2023 was analyzed. The committee found that under Choudwar, Jagatpur, Tangi Baranga, Chauliaganj, Kandarpur Police Stations, the number of accidents have been increased under DCP, Cuttack. Similarly under Banki, Salipur & Kisannagar Police Stations under SP Rural, Cuttack them accidents have been increased. Therefore RTO shall engage the NGOs working under NGO Forum Cuttack to ascertain in details and find out the solution to check the road accidents.

(Action: RTO)

14. SJEPL and other road owning authorities shall take immediate steps to clear all the passages for the pedestrians and cyclists in every river bridges.

(Action: All concerned road owning departments / SJEPL)

15. Regarding providing vehicles for joint enforcement work in and around Cuttack district by ORSS, STA, Odisha as advised by Collector & Chairman of the DRSC in the Meeting on 28.02.2023, RTO was requested the convey the decision of the Committee and write a letter to Transport Commissioner-cum-Chairman, ORSS to provide a vehicle on hire for its' use on joint enforcement work.

(Action: RTO)

16. It was decided that, all the Road owning departments or agencies will contribute certain amount of the Project cost for Road Safety. As such, Collector & Chairman suggested that all the road owning departments/agencies will provide at least 1% of the Project cost and it will be earmarked for Road safety oriented works. A letter proposal to that effect will be issued to Principal Secretary, C&T(T) Dept. and Work Department under the signature of Collector, Cuttack.

(Action: RTO)

The meeting was ended with vote of thanks to the chair and to all the members present in the Meeting.
