EOI FOR ERECTION OF FISHERIES STALL (5000 Sq. Ft.) ON THE OCCASION OF HISTORIC BALIYATRA- 2023 FROM 27TH NOVEMBER TO 4TH DECEMBER 2023 AT BALIYATRA GROUND, CUTTACK.

The District Fisheries Officer, Cuttack intends to invite sealed EOI from reputed Event Management Organizations for erection of Fisheries Pavilion to display the Departmental activities in the Baliyatra Ground, Cuttack from 27th November to 4th December 2023.

The detailed items are

1. Construction of Super Structure with German Hanger, Small stalls (Gazebo) (12ft X 10ft) 4 Nos, Wooden platform for display of aquarium with other ancillaries, lounge and central AC for Display of Exhibits.
2. Glow Upper Facia and Lower Facia as per size of the hanger with provision for Display of LED (10ft x 8ft)
3. Designing and making of Flex, Back lit and Front lit for display.
4. Providing live models on BIOFLOC, IPRAS, Cage Culture, Integrated farming & Seed production Hatcheries unit inside the stall along with light and Visual Aids.
5. Aquarium – 15 No.s (with all fittings & ornamental fishes), Floral decoration, Selfie zone creation and other decoration along with multicolor lights as per requirement.

The interested Event Managements Organization should prepare the concept note along with designing of the stall and the PPT regarding this should be presented before the undersigned at 12.30 P.M on Dt.18.11.2023 in the office chamber of District Fisheries Officer, Cuttack.

The Bidders should submit technical and financial bids separately. The technical Bid should contain all profiles, experience, GST clearance, IT clearance, PAN No etc. of the agency along with photographs of stall prepared earlier in support of past experiences. The turnover of the firm should be 50.00 lakhs Avg for last three years and the previous single work order must be more than 20 lakhs.

The financial Bid should contain the offer price including GST along with EMD amounting @ 2% of bid value in shape of bank draft in Favour of District Fisheries Officer, Cuttack for erection of 5000 sq ft stall. Sealed envelope containing EOI application along with all relevant documents should reach the O/O DFO, Cuttack through registered post/ Speed post latest by 1.00 PM on or before Dt.20.11.2023 which will be opened at 3.30 PM on the same day.

The completed stall in all respect to be handed over to the undersigned on 26th November 2023. The District Fisheries Officer, Cuttack reserves the right to alter the date of opening of EOI and also to reject any or all the EOI without assigning any reason thereof.
