Sub- Intimation regarding casting of Votes through Postal Ballots by the employees of your Office establishment as Absentee Voters in the category of Essential Service (AVES) at Postal Voting Centre to be set up at the offices of the Returning Officer of Assembly Constituencies of this District.

Madam/ Sir,

In inviting a reference to the subject cited above, I am to say that the Election Commission of India vide its Notification No. 52/2024/SDR/Vol.1 Dated 19.03.2024 have notified the following categories of electors who have employed in the essential services as a class of persons to give vote by postal ballot on being on duty on the day of poll in the current Simultaneous General Election-2024 to the House of the People and Legislative Assembly of Odisha (Copy enclosed).

- 1. Police
- 2. Fire Service
- 3. Doctors, Nurses, Pharmacists & other Paramedics of Government Hospitals
- 4. Employees of Odisha State Road Transport Corporation
- 5. Employees of Power Distribution Companies (DISCOMs)
- 6. Media persons authorised by ECI for Poll day coverage

Further, Rules 27E and 27-I of Conduct of Elections Rules, 1961 provide that the issue of Postal Ballot paper to the Absentee voters and return thereof after voting by them shall be in such manner as the Election Commission may direct. In this context, it is to inform you that, the venue for voting for Postal Ballot by AVES has been selected and fixed by all Returning Officers in their concerned office Headquarters and the dates for Postal Balloting have been finalised to 20.05.2024, 21.05.2024 & 22.05.2024 from 9 A.M to 5 P.M.
