

Sub: **Postal voting by the polling officers who are voters of 92- Niali, 94- Salipur and 95- Mahanga at different Facilitation Centres of Cuttack District.**

Madam/Sir,


In inviting a reference to the subject cited above, I am to say that as per the Notification of Election Commission of India, the last phase of Election will be held in 15-Kendrapara Parliamentary Constituency and 16-Jagatsinghpur Parliamentary Constituency on 01.06.2024. The Assembly Constituency of 94- Salipur and 95- Mahanga are coming under the 15-Kendrapara Parliamentary Constituency and 92- Niali Assembly Constituency is coming under the 16-Jagatsinghpur Parliamentary Constituency. As per the guideline, the Notification of Election of above said Assembly Constituencies and Assembly Segments were done at the later phase. However, the final round of training of the polling personnel of the District have been drafted from 14.05.2024 to 19.05.2024. As per the guideline of the Election Commission of India, all polling personnel shall be facilitated for their vote by way of postal ballot paper in the Facilitation Centre set up at the training venue. Since, the final round of training programme of the polling personnel would be completed by the 19.05.2024, the polling personnel belong to 92- Niali, 94- Salipur and 95- Mahanga may not cast their vote in the Facilitation Centre set up at the training venue as their ballot papers have not been received from the concerned Returning Officer. Hence, it was decided that 2 days special Facilitation Centre i.e., on **20.05.2024 & 21.05.2024 from 9.00 AM to 5.00 PM** would be set up at the level of all Returning Officers of the District to facilitate the postal ballot voting by the polling personnel who are electors of the aforesaid Assembly Constituencies.

Hence, you are requested to inform the employee of your office, who have opted for Postal Ballot voting & belongs to 92- Niali, 94- Salipur and 95- Mahanga Assembly Constituency to cast their vote at the facilitation center to be set up at the offices of **Sub-Collectors i.e., Cuttack Sadar, Banki & Athgarh on 20.05.2024 and 21.05.2024 from 9.00 AM to 5.00 PM.**






