Payment shall be made within 30 days from the date of receipt of bills completely in all respect along with the original rice diversion list and original rice distribution list duly certified by the concerned B.E.Os along with a certificate indicating the quality and total quantity of stock distributed subject to availability of funds.

The Transport Contractor has to claim his/her transportation bill for payment of within 60 days of delivery of mid-day meal rice at school point/TAPF godown. Beyond that period, no bills will be entertained. On demand, the matter will be reported to the higher authority for necessary order for release of payment for delivery of Mid - day - Meal rice. The District Nodal Officer, MDM - cum - District Education Officer, Cuttack shall clear the bills after due verification. The verification mechanism shall always be in operation without waiting for the claim of Transport Contractor. The payment will be made subject to availability of funds and no interest will be paid for any delayed payment. No advance payment will be made.

11. Any amount in shape of due to Govt., outstanding against the contractor/tenderer at the time of termination of contract, if exceeds the EMD, shall be recovered under the provision of OPDR Act.1962.
