Order No. 880/Res, Date 08.11.2024

**WHEREAS** the Special Bench of Hon'ble High Court of Orissa in SOU MOTU W.P.(C) PIL NO.2140 of 2020 expressed their serious concern regarding unauthorised encroachment like to be occur by the street vendors/shopkeepers on footpaths of Mahanadi Ring Road from Jobra to Chahata, Upper & Lower Baliyatra Ground and its surrounding roads during Baliyatra Cuttack Utsav 2024;

**WHEREAS** it is required to comply the observation of Hon'ble High Court of Orissa in the aforesaid SOU MOTO W.P.(C) PIL No. 2140 of 2020 for the ensuing Baliyatra Cuttack Utsav 2024 in the interest of public;


**AND WHEREAS** the Sub-Collector & SDM, Sadar Cuttack is hereby designated as Nodal officer for allocation of space to the street vendors at the earmarked area in lower Baliyatra Ground on receipt of the necessary fee. He is also directed to constitute 2 no's of squad teams for day and night comprising of RIs/ARIs/AMINs and carrying out the enforcement to removal of encroachment, if any made over the footpaths/pavements/passages etc with the help of Police personnel and CMC personnel so as to make the vehicular & pedestrian traffic movement smooth.

**NOW, therefore, I Shri Dattatraya Bhausahab Shinde, I.A.S., Collector & District Magistrate, Cuttack** in exercise of the power conferred upon U/s 163(2) of BNSS, 2023 do hereby promulgate prohibitory order to erect/install their shops on footpaths of Mahanadi Ring Road from Jobra to Chahata, Upper & Lower Baliyatra Ground and its surrounding roads as specific area has already been earmarked in the lower Baliyatra Ground for allocation in favour of the them in order to ascertain their livelihood, Necessary space will be allotted to the street vendors on receipt of the necessary user fee w.e.f from date of issue of this order till 24.11.2024.

Any person who contravenes this order shall be liable to be punished in accordance with the provisions of law.

The emergent nature of case and circumstances do not permit serving of notice to the concerned in due time and hence this order is passed ex parte U/s 163(2) of Bharatiya Nagarika Surakhsya Sanhita, 2023.


