SPOT BIDDING NOTICE

Spot Bidding for Auction Sale and Settlement of Advertisement/ Hoarding to be fixed/ installed in Upper & Lower Balijatra Ground during ensuing Balijatra Cuttack Utsav-2024 to be celebrated from 15.11.2024 to 22.11.2024 shall be held at 11.00 A.M. on 14.11.2024 in the office chamber of ADM (Gen), Cuttack.

The intended registered Firm/ Agency/ Company/ Supplier/ Vendor may participate in the Spot Bidding at 10.30 A.M. on 14.11.2024 in the office chamber of ADM (Gen), Cuttack.

Terms and Conditions of the Spot Bidding:

1. The registration for the above-mentioned Spot Bidding will be started at 10.30 A.M on 14.11.2024 in the office chamber of ADM(Gen), Cuttack.
2. The Firm/ Agency/ Company/ Supplier/ Vendor who wants to participate in the Spot Bidding must be a registered body and should have a valid PAN/GSTIN/ IT clearance certificate etc. Copies of the Registration Certificate/PAN/GSTIN/ IT clearance certificate of the firm/ Adhar must be submitted during the Bidding process.
3. The **upset amount of Rs. 7,000,00/- (Seven Lakh) only** has been fixed for the Bidder towards fixation of Advertisement/ Hoarding in Upper & Lower Balijatra Ground during the Balijatra Cuttack Utsav-2024 for the period from 15.11.2024 to till end of the Baliyatra-2024.
4. The permission for Auction Sale and Settlement of Advertisement/ Hoarding will only be issued to the successful Bidder after deposit of H-1 bidding price by 15.11.2024.
5. The selected bidder will collect the advertising cost from the intended advertisers abiding by the terms and conditions.
6. Advertisement in Upper & Lower Balijatra Ground in terms of Box Gate (Non-Light), Box Gate (Light), Flat Gate, Flex/ Banner (Fix), Multimedia (Projector), Ballon, LED be installed/ displayed in prominent places of the ground (which has not been allotted to any individual/ organization) without obstructing any view/ traffic.
7. The above-mentioned advertisement may be installed at the entry points of Lane/ Sub- Lane without obstructing smooth entry of the visitors.
8. Advertisements which hamper the view of Stages/ Cuttack-in-Cuttack and the traditional culture of Baliyatra shall not be allowed.

10. Brand-specific advertising, recognition, and preferences for **tobacco and alcohol will not be allowed in both the ground.**


11. The Electricity dues for floating of the advertisement is to be paid to TPCODL by the advertiser.

13. Collector, Cuttack reserves the right to take decisions on acceptance or rejection of any or all bidding amount without assigning any reason thereof.




