Sealed quotations are invited from intending caterers for supplying food around 2000 above members on 08.12.2024 at **Balijatra Ground, Cuttack** as per the enclosed menu, so as to reach the undersigned on or before **06.12.2024 by 11:00 AM**. The quotation should be submitted along with documents (PAN & GST).

The rate should be quoted per head including cost of bottle water (Half Ltr. Capacity), cost of the plate, logistic for distribution of food (at least 10 Nos. of counters) & cleaning of the cooking area after closure of the event. The agency will make arrangement of distribution of foodstuff engaging their resources. The quoted rate is inclusive of GST. The agency will provide disposable plates / disposable bowls / cups etc. during distribution of foodstuffs.

The quotations **will be opened at 12:30 PM on 06.12.2024** in the Office Chamber of the Addl. District Magistrate, Cuttack. Intending quotationers or their representatives may remain present at the time of opening if they so desire.

The undersigned reserves the right to accept or reject any or all the quotations without assigning any reason thereof.

1. Experience in arrangement for supply of food for cultural troupes on occasion of Govt. Programmes / similar programmes with contract value not less than 2 Lakhs shall be given preference.
2. Copy of the PAN / GST Registration Certificate.
3. In case of failure of the agency to provide proper service, the agency shall be debarred from the work with imposition of penalty as decided by Collector, The decision of the Selection Committee shall be final & binding.
4. The undersigned reserves the right to engage more than one agency if it is required at any time for better management.
