1. The bidder has to deposit tender paper cost of Rs.2000/- only in shape of D.D in favour of Regulated Market Committee, Kendupatna and payable at Kendupatna which is nonrefundable in nature.
2. The successful bidder has to deposit the security deposit of Rs.50,000/- in shape of D.D in favour of Regulated Market Committee, Kendupatna and payable at Kendupatna within 3 working days from the finalization of the quotation.
3. The Technical bid will be open first as per the prescribed date and after the technical evaluation, the price bid will be open. The Price bid opening details will be updated with prior intimation through mail to technical bid qualified bidder.
4. The bidder should be original manufacturer or their authorized dealer of the equipment stated above and providing adequate service one year after supply of the equipment.
5. The bidder has to produce documentary proof towards being manufacturer or their authorized dealer.
6. The bidder should have dedicated service centre or corporate office in the state of Odisha for delivering of speedy services. Necessary documents to be submitted for its proof.
7. The bidder has to be produced proof of successful execution of similar nature of supply for at least 3 financial year across RMCs in Odisha or any Govt offices in Odisha,
8. The bidder has to submit valid Authorization certificate from the manufacturer/ dealer/Distributor for the item quoted.
9. The supplier of Machinery/Equipment should provide both theoretical and practical training after commissioning the machinery or at appropriate stage.
10. The Bidder should submit copy of GST, PAN, ITR of last two financial year, latest GST clearance, ISO certificate and Trade License.
11. Delivery of the Equipment/Machineries within 15 days from the date of receipt of the supply order.
12. The price quoted should be inclusive of all taxes, delivery and installation.

14. Late & delayed quotation offers will not be considered at all.


15. The manufacturer/Supplier should have trained technical personnel for post service of supplied equipment.


