Sealed quotations/tenders are invited from interested Service Providers / Private individuals based at Narasinghpur for providing 01 nos. of TUV300/ Bolero/ Sumo Gold/ Ertiga vehicle including driver for official use in CDPO office, Narasinghpur on monthly rent basis which shall conform to the terms and conditions mentioned in the Annexures-1.

1. The vehicle must be in Road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
3. A sum of Rs. 1000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft / Cheque in favour of the CDPO Office, Narasinghpur and submitted along with the Quotations as EMD. After completion of tender process, the amount will be refunded to unsuccessful bidders.
4. The monthly rate of hire charge will be quoted separately in the general bid information (excluding fuel and lubricants). At no point of time the price more than the ceiling fixed by the Govt. in the latest circular shall be accepted.
5. The Vehicle must achieve a fuel efficiency of 10 KM per litre.
6. The details of the make and year of manufacture of the vehicle, registration no., mileage (KM covered per litre) and name of the Driver, Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Appendix-B).
7. The Quotation completed in all respect should reach the undersigned on or before 02.00 PM on Dt. 24.12.2024 and shall be opened on the same day at 4.00 P.M. in presence of the bidders or their authorized representatives.
8. The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with District Website of the Department/ Heads of Department/Office on payment of Rs.1000/- from 10-12-2024 to 24-12-2024 or can be downloaded from Website www.cuttack.odisha.gov.in from Dt. 10-12-2024 to 24-12-2024. In case the application form is downloaded from District website, the applicant shall furnish a Demand Draft for an amount Rs. 1000/- (Rupees One Thousand) only towards the cost of application along with the application.
