

**1. Scope of Work/Supply:-**

The Bidder will have to make “Supply and Installation of 01 no. 58.5 KVA SILENT DG SET (MAKE- KIRLOSKAR/MAHINDRA/CUMMINS or similar reputed brands) with 5 year warranty at CHC, Badamba under Badamba PS in respect of execution of MLA-LAD project for F.Y 2024-25 as per specifications prescribed in the STCN within 15 days of placing order, if selected.

**2. GST Certificate/PAN:-**

The Bidders i.e. the OEM/firm/dealer must have valid GST certificate, PAN card.

**3. Authorised Dealership/Agency Certificate:-**

The bidder must have to submit the MAC (Manufacturers Authorisation certificate In support of his Agency/Dealership of the supplied products.

**4. Submission of LT License:**

The intending bidders have to submit LT License issued by Chief Electrical Inspector, Odisha in support of execution of installation of DG Set with three phase connection.

**5. Cost of Bid/Quotation Paper:-**

The Bidders intending to participate shall have to submit the Quotation/Bid paper cost of Rs.4,000/- (Rupees Four Thousands) only in favour of BDO, BADAMBA in shape of Demand draft from any nationalised /scheduled bank payable at Badamba along with their quotation/Bid document.

**6. EMD (Bid Security):-**

The Bidder shall have to submit EMD of Rs.10, 000/- (Rupees Ten Thousands) only in favour of BDO, BADAMBA in shape of demand draft from any nationalised /scheduled bank payable at Badamba along with bid otherwise the bid will be liable for rejection.

**7. Performance Security Deposit**

The Successful Bidder shall have to submit Performance Security Deposit (PSD) @ 5% of the L-1 approved cost in shape of STDR/FD duly pledged in favour of BDO, BADAMBA from any nationalised /scheduled bank at the time of execution of agreement for supply. The PSD is refundable after the expiry of warranty period.

**8. Affidavit in support of "NRC" & submission of "Authentic Documents":-**

(I) The Bidder shall submit on affidavit to the effect that the documents submitted with this Bid/Quotation are authentic & genuine. If any canvassing found thereof his participation will be stand cancelled.

(II) The Bidder need to submit an affidavit in support of "No relationship Certificate" with declaration that, "He has no relationship in any manner with the officials not below the rank of Assistance Executive Engineer and above of the Panchayat Samiti".

**9. Instructions to Bidders:-**

- Bidders desirous for participating shall have to pay the cost of Bid Paper mentioned in STCN. The Bid paper cost is required to be paid in shape of Demand draft only, drawn from any nationalized/scheduled bank in favour of BDO, BADAMBA which must be payable at Badamba.
- Earnest money as specified in Tender shall be deposited in shape of Demand Draft/ STDR from any nationalized/scheduled bank in an acceptable form at the time of submission of Tender.
- Since, timely execution of works is the essence of the contract, requests for extension of time shall not ordinarily be entertained.
- Notice inviting Tender, Tender documents, terms & conditions shall form the part of the Tender.
- The price quoted by the Bidders shall be inclusive of all taxes, transportation.
- Deviations in terms and conditions will not be accepted under any condition.
- Prices quoted must be firm and final. It shall be quoted in both figure and word. It should be inclusive of GST.
- Canvassing in any manner will be viewed seriously leading to rejection of the Tender.
- The bidder is required to self attest all the pages in his bid document submitted to the appropriate authority.
- The bidders are required to submit Printed brochures of the OEM of the products along Certified Price list of the OEMs for the authorized dealers/agencies.

**10. Settlement of Dispute:-**

In case of any dispute arises between the supplier and purchaser shall be tried to resolved amicably by mutual understanding. If the parties fails to resolve the dispute within 21 days shall be settled through arbitration under the jurisdiction of Nuapada Court only as per Indian Arbitration and Conciliation Act-1996.

Payment shall be made only after received of the materials as specified and as per requirement mentioned and if found satisfactory and proper installation of the products.
