The undersigned reserve the right to accept or reject any or all the quotations without assigning any reason thereof.


Terms and Conditions:


7. Advertisements which hamper the view of Stages/ Cuttack-in-Cuttack and the traditional culture of Baliyatra shall not be allowed.


