


## GENERAL TERMS AND CONDITIONS

1. The articles put to tender will be disposed off **“AS IS WHERE IS BASIS”**.
2. The intending bidders may inspect the articles in the premises of District Vaccine Store, Nayabazar where it is kept with permission of concerned authority within office hours.
3. The intending bidders shall have to deposit earnest money @ Rs.3,000/- per bid in shape of bank draft in any nationalized bank in favour of **“ZSS DEPOSIT ACCOUNT, CUTTACK”**. The bidder may submit the EMD in consolidated manner for the all the article quoted in the bid.
4. EMD of unsuccessful bidders will be returned without interest after finalization of tender. EMD of successful bidder will be retained as Security Deposit & will be refunded without interest only after the successful removal of the articles against deposit of full amount as finalised in the auction along with GST and other dues if any. The security deposit is liable to be forfeited if bidder violates or fails to comply with the terms and conditions of the tender.
5. The bidders, quoting highest price subject to above the price fixed by the authority, shall deposit 25% of the offered amount with the **“ZSS DEPOSIT ACCOUNT, CUTTACK”** immediately on confirmation of the acceptance of the tender by the CDM&PHO Cuttack in shape of Demand Draft and the rest amount should be deposited within 7 days of above date of submission. On failure of the timely payment of the amount as aforesaid, the article including the earnest money shall be forfeited and the vehicle will be put to fresh tender.
6. The tender will be opened on scheduled date and time in the office of the undersigned in the presence of bidders or their authorized representatives. In the event of the date being declared as holiday for Govt. of Odisha, the due date of submission of bids and opening of bids will be next working day.

The bidding documents complete in all respect should reach to the O/o. - CDM&PHO Cuttack (District Programme Management Unit.), Cantonment Road, Buxi Bazar, Cuttack - 753001 by 2.00 P.M of 11.11.2025 through Speed Post / Regd. Post / Courier only and super scribed as **“BID DOCUMENTS FOR AUCTION OF COLD CHAIN ITEMS”**. The authority has no liability regarding postal delay. The bid will be opened on 11.11.2025 at 3.00 P.M in the office chamber of the undersigned. The articles will be handed over to the successful bidders after making full payment of the accepted tender money.
8. The CDM & PHO, Cuttack will have no liability regarding transportation, loading, unloading or any other incidental charges (if any) with regard to articles under auction.
9. The bidder should furnish Photo copy of PAN and GST along with the bid.
10. The bidder shall remove the articles from the site within 07 days of confirmation letter from the undersigned.



11. In case the bidder whose tender is accepted, fails to remove the articles from the office campus within stipulated time he/she shall pay ground rent @1% of his quoted price per day. If the ground rent so charged exceeds the amount deposited by the highest bidder the bidder shall cease to have any right on the article and the amount deposited by the bidder shall be adjusted towards ground rent and the vehicle shall be absolute property of the undersigned.
12. The bidder offering highest prices will be selected. If offered price lower than the off-set price then the committee have the liberty to negotiate with the bidders and finalise the tender.
13. All documents submitted must be signed by the authorised signatory of the organisation with seal.
14. The bidder should present in the tender opening personally or through authorised representative with due authorisation letter otherwise bid will not be accepted.
15. If there is any contradiction between price quoted in figure and word then price quoted in word shall prevail over price quoted in figure.
16. The CDM&PHO, Cuttack reserves the right of rejecting any of the tenders without assigning any reason thereof.
17. All the correspondence on the tender and disposal of the article is to be made with the CDM& PHO, Cuttack.
