The intended registered Firm/Agency/ Company/ Supplier/ Vendor may participate in the above scheduled Spot Bidding.


Terms and Conditions of the Quotation:

1. The registration for the above-mentioned Spot Bidding will be started at **10.30 AM on 31.10.2025 in the Office chamber of Addl. District Magistrate (Gen.), Cuttack.**
2. The Firm/Agency/ Company/ Supplier/ Vendor who wants to participate in the Spot Bidding must be registered body and should have a valid PAN/GSTIN/IT Clearance Certificate etc. Copies of the Registration Certificate/ PAN/GSTIN/IT Clearance Certificate of the Firm/ Aadhar must be submitted during the Bidding process.
3. The **upset amount of Rs. 8,000,00/- (Eight Lakh) only** has been fixed for the Bidder towards fixation of Advertisement/ Hoarding in Upper & Lower Baliyatra Ground during the Historic Baliyatra Cuttack-2025 for the period from 05.11.2025 to till end of the Baliyatra-2025.

13. Collector, Cuttack reserves the right to take decisions on acceptance or rejection of any or all bidding amount without assigning any reason thereof.


